

SOCIAL AID APPLICATIONS AND ROLES OF NON-GOVERNMENTAL ORGANIZATIONS IN NATURAL DISASTERS

Introduction

Disasters have preserved their existence from ancient times, sometimes they were expressed as an inevitable situation, and sometimes they were described as human-induced and preventable events. In this context, regardless of the source of disasters, they are undesirable situations by the society with some economic, social and psychological losses. Disasters that occur as a result of natural conditions such as climate and drought or the geological behavior of the earth, and sometimes as a result of reasons prepared by humans; It has heavy material and moral consequences and often devastating effects on societies (Altun, 2017).

The International Disasters Database reported that in 2019, at least 396 natural disasters affected 95 million people. It has been reported that in these disasters, approximately 130 billion dollars financial loss occurred and 11,755 people died (Center for Research on the Epidemiology of Disasters, 2020). Considering World Bank data, more than two million people have died and more than \$ 3 trillion have been lost due to natural disasters since 1980. While the total loss was \$ 23 billion in the 1980s, it has increased by more than 600% in the last decade to \$ 150 billion (Center for Research on the Epidemiology of Disasters, 2020). All these negative results reveal the potential threat that disasters pose on societies.

The adverse life conditions that occurred after events such as wars, disasters, and crises throughout the history of humanity put more responsibility on the shoulders of the social welfare state, and the social welfare state saw social assistance as the most important tool to end these responsibilities (Dursun,2020b; Yay, 2015). Although the financial losses experienced after the disaster are important for the individual, it is also seen that these losses can be compensated over time as long as the spiritual integrity of the individual can be achieved. In spite of this situation, it is thought that if an individual who loses his / her psychological and social balance after the disaster cannot be intervened urgently, he / she will be deprived of living a healthy life for the rest of his / her life. In this case, the importance of social assistance and Non-Governmental Organizations (NGOs) becomes clear.

1. Conceptual Frame

1.1. Disasters

When the definitions related to the concept of disaster are examined, it is seen that disaster is mostly defined in the context of its effect on people. Disaster and Emergency Management Presidency (AFAD) disaster; It is defined as situations that create significant economic, social and psychological effects in the whole or a large part of a society, interrupt the daily flow of life or stop it completely, as situations where coping capacity is often insufficient (AFAD, 2020).

Disasters cause disruption in the social order with material and moral losses in the European Atlantic Disaster Response Center Directive; earthquake, flood, forest fires (non-human), avalanche, landslide, tornado, volcanic eruption, etc. As well as being naturally sourced, mining accidents can be caused by humans for technological reasons, based on nuclear, chemical, industrial accidents. In addition, terrorism and war situations are determined within the scope of disaster with the sudden effects they create on society (De Siervo, 2012).

By the International Federation of Red Cross and Red Crescent Societies (IFRCRCS), a disaster is defined as a situation or event that exceeds local capacity, and it is stated that the disaster has two types of natural and unnatural. Natural disasters are divided into hydro-meteorological and geophysical, and hydro-meteorological natural disasters; They are grouped as avalanches, landslides, drought, hunger, extreme temperatures, floods, forest fires, storms and others. In terms of geophysics, it is stated that natural disasters are earthquakes and volcanic explosions. Unnatural disasters are divided into three groups as industrial, various and transportation-related disasters. Industrial disasters are considered as chemical leakage, collapse of industrial structures, explosion, fire, gas leakage, poisoning and radiation, and a wide variety of non-natural disasters are indicated as collapse, explosion or fire of domestic / non-industrial structures. The third and last category of non-natural disasters caused by transportation includes disasters that occur due to accidents experienced during airline, rail, road and waterway transportation (IFRCRCS, 2020).

1.2. Social Aid Applications in Disasters

Social Assistance is the whole of public activities carried out to provide free financial and social support to people who cannot find the means of subsistence even at a minimum level within local standards due to reasons that are not in their own hands, based on neediness researches, as soon as possible. Social assistances are in-kind and in-cash aids made to provide a living level worthy of human dignity for those who are unable to provide for themselves and their dependents, for reasons beyond their control, at a minimum standard of living.

To be more detailed according to the World Bank classification; social helps; Conditional and unconditional cash transfers such as cash transfers targeting the poor, old-age and disabled payments, family and child benefits, student scholarship, housing support, martyr and veterans aids, funeral and burial aids, food aid, free book distribution, nutrition assistance for students, emergency response and disaster relief, aid in return for working for the benefit of the community, education, health, transportation and housing expenses, social care services for the elderly, disabled and children (The World Bank, 2018).

Social assistance for disasters can be divided into three as what to do before a disaster, what to do in case of a disaster, and what to do after a disaster. The purpose of pre-disaster social assistance is to take measures to reduce the disaster risk and loss of life and property in the event of a disaster. Studies show that the cost of precautions to be taken before the disaster is much lower than the cost of social assistance and reconstruction works after the disaster. Therefore, pre-disaster risk reduction policies are of primary importance among disaster policies. However, although measures are taken to reduce risk in the pre-disaster period, it is

always possible for disasters to occur and an effective policy should be followed for what to do in the post-disaster period.

Disasters often affect public life and disrupt daily life. Therefore, as a result of disasters, many people are in need and need social assistance. Aids needed after a disaster vary according to the type of disaster, its impact and the place where it occurred. The Convention on Minimum Standards in Disaster Response and Humanitarian Aid has been signed by aid organizations, including international Red Crescent and Red Cross organizations, in order for the disaster victims to live with dignity (Geneva, 2000; full text: SPHERE Project). The main purpose of this convention is to provide the necessary assistance for the individuals who are exposed to disasters to return to their pre-disaster lives and to consider living conditions suitable for human dignity while providing these aids (SPHERE, 2000).

Humanitarian Aid Convention; The International Convention on Human Rights defines the basic principles of the humanitarian movement and the rights to aid and protection that society needs, based on the Law on Refugees and the Legislation of the Executive Law for Non-Governmental Organizations in Disaster Relief and the International Red Crescent and Red Cross Movement. In the contract, minimum assistance to people affected by disasters; water, hygiene, food, nutrition, shelter and health services. Besides the aids specified in the Humanitarian Aid Convention; other assistance to be given to the victims in the disaster area; educational aids and psychological support. Disasters cause great psychological damage and these destructions prevent a person from continuing his normal life. In the disaster area, a number of services are provided to make everyone, especially children, widows and those who lost their relatives, forget the pain of the incident and return to their pre-disaster life.

1.3. Non-Governmental Organizations in Disasters

Although there is no obvious explanation, NGOs can be defined as non-profit organizations operating on a voluntary basis for the public benefit. Non-governmental organizations are extremely sensitive to natural disasters. In addition to the fact that there are many organizations established to assist in disasters in our country, apart from these organizations, non-governmental organizations whose main task is in another field also support relief efforts during and after disasters. The main role of non-governmental organizations in disaster situations is to act under the guidance of central and local administrations and to assist these administrations. Almost all of the NGOs working in support continue their activities on a voluntary basis.

Non-governmental organizations operating in disasters and response to disasters have a field of activity starting from local to national and supranational scale. The field of activity of NGOs organized in the neighborhood is mostly limited to the area where they are organized. However, NGOs operating in different types of services and being organized at national level also operate within national borders and, if needed, at international borders in accordance with their working capacities and cooperation.

NGOs operating in disasters can generally be grouped as follows;

- Organizations whose field of activity is not directly related to disasters (aid organizations, etc.)
- Organizations whose field of activity intersects with disasters and are aware of disaster management processes (organizations operating in the fields of support services, education, health, etc.)
- Local and national organizations based on disaster preparedness / emergency response (search and rescue, emergency medicine, communication, etc. organizations)
- National and international organizations providing humanitarian aid services (Dursun, 2020; Kaya, 2013).

There are organizations that have an important place in determining the policies for disasters in the world.

International Organizations

a) UN System

The United Nations is an inter-governmental organization that emerged after the Second World War, that produces and implements projects on a global scale to respond to disasters, protect generations and provide better living conditions.

b) Civil Society Organizations International Red Cross and Red Crescent Movement

International Red Cross and Red Crescent Movement; Carries out humanitarian aid activities regardless of language, religion, race, class or political opinion. It contains 3 separate corporate structures within its structure.

- I. International Committee of the Red Cross (ICRC)
- II. National Red Crescent and Red Cross societies
- III. International Federation of Red Cross and Red Crescent Societies (IFRC)
- c) *United States Agency for International Development (USAID)*
- d) *International Financial Organizations*
 - I. World Bank
 - II. International Monetary Fund
- e) *NATO*

National Organizations

a) Search and Rescue Association (SRA)

In case of disappearances and accidents occurring in mountain and natural conditions, natural disasters such as earthquakes, floods and major accidents, voluntarily, with an amateur work and a professional approach, reaching people in trouble as soon as possible, creating appropriate conditions for assistance, right The general purpose of the association is to provide basic first aid support to the victims by carrying out search and rescue activities and to ensure their transfer to safe environment conditions, to minimize the loss of life in such incidents and to inform our society about search and rescue issues.

b) National Medical Rescue Team (NMRT)

In Turkey after the earthquake that occurred in 1999, the institution of emergencies and disasters on the restructuring; National Medical Rescue Team (NMRT) was established in 2004 in order to respond quickly and accurately to people exposed to disasters within the scope of the Health Organization Project in Disasters, carried out by the Ministry of Health, General Directorate of Primary Health Services, Department of Health Services in Emergencies and Disasters. Within the General Directorate of Emergency Health Services, under the Disaster and Emergency Management Department, it has the capacity to work 24 hours a day in emergencies, disasters and extraordinary situations in national and international areas with approximately 490 personnel in 21 regions and 81 provinces.

c) Turkey Red Crescent Association

Turkish Red Crescent has one of the best disaster organizations in the world with the disaster response and disaster logistics systems it has spread throughout the country. Turkish Red Crescent provides emergency nutrition services to the victims after natural disasters occurring in the country. In terms of emergency accommodation, it assumes an auxiliary role beside the relevant institutions of the state. The Turkish Red Crescent, which expands disaster response and disaster

logistics systems throughout the country and has one of the best disaster organizations in the world with this network, reaches the disaster area in the shortest time thanks to 9 Regional and 23 Local Disaster Response and Logistics Centers.

The Turkish Red Crescent, which meets the urgent needs in the region after the disaster, stands by the disaster victims with high quality and fast service with the Mobile Bakery Oven, Mobile Kitchen and Mobile Catering Vehicles in the field of nutrition. Turkish Red Crescent, which has tent enterprises and production workshops in Ankara and Erzincan, produces special tents for needs as well as disaster tents that can be used for long-term domestic and international humanitarian aid efforts.

d) Disaster Risks Reduction Platform (AFAD)

It was established in order to increase the sensitivity of the society to disasters and to ensure continuity in risk reduction activities, to determine the needs in order to ensure that the principle of risk reduction is taken into account in plans, policies and programs at all levels, to monitor and evaluate practices. The Platform, which was established in 2011 and has 53 members, gathers at least once a year and its secretariat services are performed by DRRP.

Result

Throughout history, humanity, who has been exposed to many disasters and has gained great experience in combating disasters, has understood the importance of international solidarity and holistic response in disaster response. With this understanding, although the types of disasters are different, their effects are mostly common. In this context, a holistic response is required for all disasters, whether natural or man-made, before, during and after the disaster. Social assistance and non-governmental organizations play an important role in this holistic intervention. The role and importance of non-governmental organizations in the execution of these aid activities is magnificent.

The physical, economic, social and psychological effects of disasters are seen as the problems that societies must first overcome. In order to minimize the damages of disasters, each society has developed different disaster management systems according to its geographical conditions, experiences and socio-cultural structures. Disaster response approach and disaster management systems that have been created are moving towards a common ground with globalization. Besides these, interventions against disasters have started to be seen as an international problem rather than a national issue.

Təbii fəlakətlər zamanı sosial yardımların həyata keçirilməsi və Qeyri-hökumət təşkilatlarının rolu

Təbii fəlakətlər normal həyatı alt-üst edən, insanları fiziki, sosial, iqtisadi və psixoloji cəhətdən zərər görməsinə səbəb olan böyük hadisələrdir. Xüsusilə də müasir zamanda texnologiyanın inkişafı ilə parallel olaraq, insan resurslarından qaynaqlanan fəlakətlərin ortaya çıxması ilə birlikdə daha çox təbii fəlakətlərin yaranmasına səbəb olması ilə üz-üzəyik. Dünyada və Türkiyədə hər il təbii fəlakətlərdən ciddi şəkildə əziyyətçəkən insanların köməyə ehtiyacları artır. Köməyə ehtiyacı olan zərərçəkən insanların ehtiyaclarını ödəmək - sosial müdafiə sisteminin əsas problemi. Təbii fəlakətlərdən sonra verilən yardımlar ümumilikdə sosial müdafiə sistemi daxilində sosial yardım və sosial xidmətlər vasitəsilə təmin edilir.

Осуществление социальной помощи при стихийных бедствиях и роль в этом неправительственных организаций

Стихийные бедствия - это крупные события, которые нарушают нормальную жизнь и причиняют людям физический, социальный, экономический и психологический вред.
