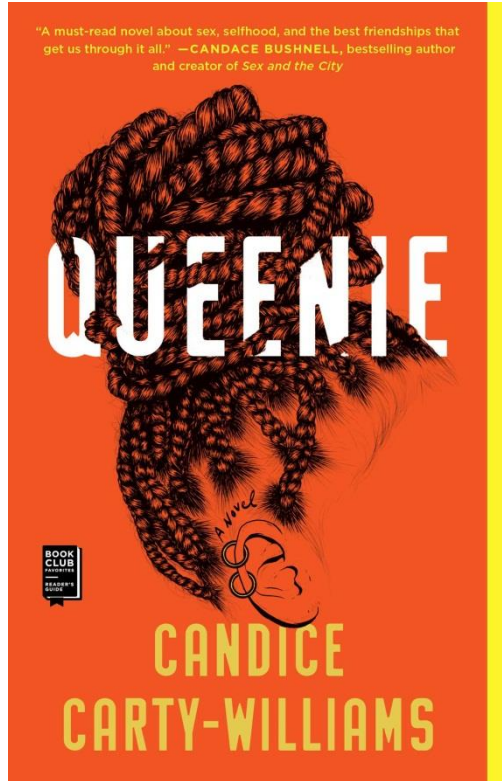


## Book review:



### Queenie

## Structure

This book review seeks to cast light on Candice Carty-William's critically acclaimed novel: *Queenie*, written against a backdrop of 'Black Lives Matter.' It tells the story of twenty-five-year-old Queenie Jenkins hailing from a broken, black, Jamaican family living in England. The novel accentuates the predicament of a young black woman suffering from racism and sexual abuse in a supposedly democratic society. Nevertheless, the novel is not wholly dark and bitter since the novelist believes in recuperation and optimism. The novelist implies that doubly oppressed black women due to their race and gender can transcend their plight and begin a new lease of life like Queenie. Indeed, the novelist aims to instill confidence into women especially black women. Even though the novel's sisterhood, feminism, and anti-racist discourse are laudable, the novel's lack of subtleties in dealing with racism is still perceptible. On the whole, the novel is well-written and relevant to our era.

## Content

This realist novel relates the tale of 25-years old Queenie Jenkins through the first-person point of view. She hails from a broken black Jamaican family. It is set against the backdrop of the Black Lives Matter movement in England and is nurtured by the philosophy of black feminism as well as black is power. The novel begins when the protagonist has a normal relationship with Tom, her white boyfriend, in their apartment; however, it gets bitter and pathological when Tom leaves Queenie. She is hopeful that he will return after some weeks. Contrary to her expectation, he does not appear. To her chagrin, Tom does not respond to her calls, messages, and emails. Her absence makes her recollect her memories with him through flashbacks that shed light on their pleasant and unpleasant memories. The passage of time does not heal her situation, instead aggravates it. After Tom's departure, she has a miscarriage and loses the apartment. Accordingly, she looks for a new place. Wherever she goes, she encounters racism.

The white people prejudice her as a loud, smelly, violent, and undesirable black girl. For instance, a lesbian couple whom Queenie wishes to be roommates humiliates her by asking whether she shaves. Then they warn her that their draining system is too delicate to cope with her thick hair. Still worse, she feels sexually void and strives to fill it via having liaisons with strangers with whom she gets familiar through OkCupid, a dating application. Her temporary partners dehumanize her and discard her after their carnal gratification. Moreover, they view their sexual affair with her in light of racism. In their eyes, black women crave white men and relish violent copulation. One can see a similar sense of sexual emptiness and disorientation in Tennessee Williams' *A Streetcar named Desire*. Step by step, Queenie loses control of her life. To find a plausible solution, she visits the sexual health clinic at the request of her close friends, to whom she confides her dates through Whatsup messenger. Again, she experiences blatant racist behaviors by the doctor and nurses there.

They assume that some violent black men are behind debauchery and her sexual damages, while her partners have been some white men. She is not immune to the immoral proposal, even in her workplace. For instance, Ted, her colleague, lures her into lovemaking resulting in her career suspension in a local news agency. She describes her dire situation as falling apart, which brilliantly alludes to Chinua Achebe's novel: *Things Falling Apart* in which Achebe charts socio-cultural traumas and devastations by the British colonial regime in Africa. During her unemployment, she joins her grandparents. Her brief stay with them enables the narrator to introduce their life story both in Jamaica and England, her parents' unhappy and violent marriage, and their eventual divorce, as well as her aunt and teenage daughter. By doing so, the novelist holds a mirror to the life of three generations of English Jamaicans and reflects their hardships and resilience in the face of racism. Though Queenie's life is rife with miseries, it is not devoid of a dramatic change. It is Dr. Janet Cosima, her new therapist-cum-counselor, who triggers it. She acts as an archetypical wise woman, the reverse of the Jungian wise old man. She genuinely guides her and treats her as her daughter. She is the only character that does not fall into the trap of racism in dealing with Queenie.

Thanks to her mentoring and monitoring, Queenie gradually finds her life direction and regains her lost confidence. The turning point of the novel takes place when Queenie holds her birthday party. The event is symbolic since it harbingers her new birth. Also, it connects her with her mother. From that point onward, she becomes more disciplined in her life and workplace. Accordingly, she resists carnal temptations and initiations. Instead, she yearns for a healthy relationship in which respect and humanity rule supreme even though she does not find it. When her suspension ends, she returns to her workplace and resumes her job with stamina, and gets a promotion. To her surprise, her mother receives compensation for her apartment taken illegally by her indifferent and unfaithful father. She gives it to her daughter to rent a decent place. The happy ending of the novel bears testimony to the possibility of change and progress for the racial minorities.

### **Future**

This novel is inspirational and didactic. Though its scale and theme are universal, it targets black females and encourages them to fight against racism and transcend racial stereotypes. It is a black feminist work because it illustrates that black women go through double oppression due to their race and gender. Nevertheless, it highlights its positive side too. In this novel, positive characters are female, and their sisterhood is productive, whereas the negative ones are men whose intimacy is motivated by erotic urges and unable to establish healthy relationships with women. Unlike the classical realistic novel, this novel is austere in terms of description. Instead, it relies more on dialogues, which bestow a dramatic quality on it. It moreover permits the novelist to acquaint her readership with the colloquial language and mindset of her immigrant grandparents. Thus, it grants an anthropological slant, albeit amateurish. At times, her grandparents' religiosity and traditional beliefs add humor to the novel because they are at variance with the modern lifestyle. For instance, for them, therapy and sexual counseling are useless and unimaginable, or when they drink wine unwittingly in their family gathering, they think that they have consumed poison. The novelist also capitalizes on an old popular technique of epistolary; nevertheless, in place of handwritten letters, characters communicate through emails.

Another prominent feature of this novel lies in its frank and vituperative rhetoric. Despite its many positive qualities, the novel sometimes suffers from the lack of subtleties in its dealing with racism. The vision of the novel, at times, is black and white though its picture and philosophy are relevant to our contemporary world rampant with racism.
