

THE RANGE OF CULTURAL AND SOCIAL ACTIVITIES OF MUSLIM WOMEN; IN THE CONTEXT OF WOMEN'S ACTIVITIES AT THE FOREFRONT OF ISLAM

Introduction

Men and women are both human beings and members of the human community. Islam has considered equality between men and women in human rights. Both can be rewarded instead of righteous deeds and punished in case of disobedience. Women in Islamic society have the same religious, economic, and social rights as men. It can play a positive role in social development and structure. Although in Islamic society, some matters are related to men and some are related to women, there are some matters in which men share equal weight. In the first step, women are the trainers of generations, the educators of men, and heroes. It is not possible to ignore the role of women in Islamic social life. To understand the position



of women in Islam, it is worth mentioning that women are also obliged to perform most of the Shariah duties that Allah has made men perform. Most of the Quranic verses are addressed to male and female believers, and few verses can be found that are only related to men. Prominent men have worked side by side in various activities of promoting religion and science, creating civilization, and expanding culture. Human activities, both male and female, are extensive and include all aspects of life, both social and cultural. The Holy Quran also points to the wide range of human activities and says, "By the One who created male and female, your efforts are scattered" (Holy Quran, verses 3 and 4).

In the history of Islam, women have played an important and influential role in Islamic society. They have contributed and made efforts in the expansion of science, culture, civilization, economy, and social development in different stages and periods of Islamic history. The example of the first activity and effort of women to accept the call to Islam and the confirmation of the Prophet's t by Khadija Al-Kubari. He not only accepted the call of Islam but also comforted the Prophet and gave him spiritual and material help in fulfilling his mission. Shafa daughter of Abdallah Adawiya is a woman who taught Hafsa, the Prophet's wife, to read and write by the order of the Prophet (Balazari, 1975, 3, 580). For this reason, Hafsa is considered one of the owners of the Quran (RamYar, 1369, 385).

Scholars have written about the various activities of women at the beginning of Islam. Among these writings, we can mention the period of al-Marah fi Dawah to God in the light of al-Kitab and the Sunnah by Qavifli and the military presence of women at the beginning of Islam by Jalali Kandari, etc. However, none of the mentioned writings have addressed the scope of women's activities in early Islam, which forms a framework for the activities of Muslim women today. This research was written to explain the range of social, educational, economic, and political activities of women in the framework of Islam and answer the question of the extent of social activities, function, and education of women in Islam. The research method of this discussion is a library written in descriptive-analytical form.

1- Definition of culture

Culture, like other sciences, has various and different definitions. Every scientist has looked at and defined culture from a different angle.

1-1 The word of culture

Culture is the Latin equivalent of Educate-Education, which is used in the meaning of drawing, education, training, science, and politeness (Dehkhoda, 1342, 904 under the word culture) Culture includes science, knowledge, politeness, knowledge, education, training, scientific and literary works of and It is tribe and nation (Omid, 1360, 769). The equivalent of culture in the Arabic language is culture. Culture is derived from the root thaqf, which means skillful and skilled in understanding things (Ragheb Esfahani, 1412, 173). Culture is

also used in the meaning of swordsmanship, skillful and clever person, victory and victory, coincidence, victory in science, and knowledge (Ibn Manzoor, 1414, 9/19). Currently, culture is used in the word to mean the skill and speed of acquiring and understanding science. When it is added to a specific science, it is called jurisprudential culture, historical culture, etc (Al-Samrai, 1404, 7).

1-2 Culture in the term

In the term, culture is the achievement of human societies, including theoretical knowledge and practical experiences, which open the way for man to think and shape his behavior in different ways of life (Al-Samrai, 1404, 8). Culture is the set of material and spiritual values of society, created by humans throughout human history. By saying that every culture at any point in time shows the level of people's understanding of their surroundings and shows scientific and technical progress, knowledge, ideals, art, and tolerance. Culture explains the way of life that each nation and society has for itself (Shefa'i, 1401, 49). Culture includes everything that enlightens the mind, cultivates talent, and develops the queen of criticism and judgment in the individual and the complex; In other words, culture is a complex whole that includes knowledge, ideas, art, ethics, law, customs and other abilities (Al-Samrai, 1404, 8).

1-2 Islamic culture

Islamic culture is a living interpretation of the main concepts related to the belief and goals of the Islamic Ummah, which is determined to defend the belief of the Islamic Ummah and institutionalize it in the institutions of the people and discover all the threats that have put the Ummah under pressure (Al-Samrai, 1404, 9). Undoubtedly, Islamic culture is one of the theoretical and practical aspects of the human and intellectual heritage that has been assigned to and attributed to the Islamic Ummah, and a Muslim interacts with it from the time of his birth to his death. Islam is a religion that created culture. Culture is the fruit of all knowledge, and at the head of every culture is religion in the general sense of that convention, which is human nature, whatever religion it is. Due to its inclusiveness, it keeps the unruly egos of humans from being in whims and caprices and prevents the holder of the ego from suffering from defects and ugliness (Bikthal, 2021, 7).

National culture and religion are dual manifestations of a single object because culture includes religion in its essence, that is, culture contains religious information (ibid, 8). Islamic culture presents a comprehensive picture of Islam before going into religious details. Islamic culture does not discuss monotheism, jurisprudence, interpretation, hadith, and other Islamic sciences in a detailed and specialized manner, but it expresses the general content of the mentioned sciences to know the truth of Islam, the spirit of Islamic culture and civilization (Uthman, 1403, 7).

2- The social position of women from the perspective of Islam

The life of the world, including good and bad, difficulty and ease, sorrow and happiness, comfort and suffering, life and death are not exclusive to men only, but women also share in all of them as members of society and fellow travelers of men. As two stakeholders of human society, both spectrums are helpers, collaborators, and partners in attracting benefits and reaping corruption. Partnership requires that each of the partners share in doing the work, receiving a salary, and working hard based on their share and benefit, while they may differ from each other in terms of strength, talent, and ability. Therefore, fairness is to consider the rights and responsibilities of each person in proportion to the necessity, power, effort, and duties he has performed. Islam has respected this importance and called people to do it, has given everyone their full rights without prejudice, and has called everyone to the duties and actions commensurate with the talents that God (J) has institutionalized in their existence (Al-Samrai, 1404, 81).

Islam's view of man is firstly based on his human values, which are never separated from him, and secondly, it is based on his real duties in the family and community environment. According to Islam, humanity is the most important common feature of these two spectrums. Because both of them are human beings, they are examples of God's caliph on earth. The responsibilities and roles of each depend on the same example. The result of the sharing of man and woman in human nature is that whatever is fixed for man, regardless of other characteristics, is fixed for those two groups of men and women who share humanity. The human soul of both the male and female spectrum can reach closeness to God, which is human perfection, through the spiritual nourishment that is achieved by fulfilling religious duties, and the manifestation of his name and attributes. Therefore, each of the prominent men has had a social role throughout history. One of these social roles of women after Islam are the spread of Islamic culture by women and by them to women and men in society, especially since women, in addition to their social presence, are also responsible for raising the family. Based on this, the view of the Holy Quran towards women can be divided into two types. In the context of the Quran's attitude towards women in terms of their human value, it should be said that the Holy Quran first introduces the creation of women as men, independent and both from the same essence and essence. And in this sense, it is no different from a man, and in the verses of the Holy Quran, it is the man who is addressed, and the divine address when talking about human values, is expressed in a general way (Bakhtiari, Rezaei 2011, 64).

It has been pointed out that according to Islam, women are effective members of society and should play a role in important social issues like men. A look at the life of Khadija Al-Kubri, the first great lady of Islam, and her unwavering help to the Messenger of God in the advancement of Islam and the role of other wives of the Prophet in the defense of Islam and the spread of Islamic culture, as well as the role of His Highness's daughter, Fatima Al-

Zahra, in the spread of Islamic culture and the role of Zainab al- Kobra This is important in the incident of Karbala and the events after it. A woman, namely Khadija Al-Kubari, confirmed and supported the Prophet from the very beginning of his mission and the revelation of verses from the Quran. Tajai contract, the Prophet named the year of Khadijah's death, i.e. the tenth year of the Prophet-hood, Aam al-Hazen (Saba'i, 2015, 49). Khadija Al-Kabri is an outstanding example of a Muslim woman who has done her duties well to strengthen the foundation and foundations of the nascent Islam. Khadija played a prominent role in establishing the foundations of the Muhammadan mission and institutionalizing the Prophet's call among the people. For this reason, Khadija's role in the strengthening and expansion of Islam and religious culture is unique and in loyalty, sincerity, jihad, and sacrificing her life and property for the cause of Islam, has become proverbial (Al-Quwaifli, 1409, 779).

The extensive activities of women in various cultural and social sectors go back to the very first years of the mission. According to Balazhari, some women who were literate in Islam were commissioned by the Prophet to teach science to others as well (Balazeri, 1975, 3/580).

3- The role of women in different cultural fields at the forefront of Islam

Arab societies were primitive societies at the beginning of Islam. In these societies, activities were carried out based on tribes. The men of the community were busy with livestock, agriculture, war, and defense, sometimes writing poems and speeches, trading, etc. When the Prophet was assigned to call people, things like calling Islam, writing the Quran, jihad in the way of God (J), participation in religious affairs, etc. were added to the previous activities. In the city of Makkah, due to the secret making and the lack of a specific place for cultural affairs, religious propaganda first took place secretly and then publicly, but when the Prophet migrated to Medina, the first step was to build the Prophet's Mosque - a place for worship, religious and cultural propaganda and Making political and social decisions. Only Mosque was the center of worship and the largest institution where religious and cultural propaganda was carried out. Women in the mosque participated with men in congregational prayers and other religious and cultural activities. Hajj was another place to propagate and spread the religious and cultural call of Islam, where women shared with men. The desire of women to attend the Hajj rituals can be well witnessed by the presence of the Prophet's wives during the Hajj days with the Prophet and after his death and the participation of women in various trips with men (Ibn Saad, 1968, 8/166). The widespread presence of women in various religious and cultural activities in the Prophetic era can be seen in Bayat al-Nisa (Maghrizi, 1420, 398/1).

4- The role of women in Literacy, Teaching, Writing, Narration, and Fatwa

Women have participated in the narration of hadith in various cultural fields, including literacy, teaching, writing books, etc. which is discussed below.

4-1 Education and training

According to Balazhari, a historian of the 3rd century of Hijri, women had the benefit of reading and writing before the Prophet (Balazhari, 1975, 580/3).

The Prophet, whose invitation started with reading, supported the education of all people, especially women. In addition to encouraging all Muslims to study with the famous hadith, "Learning knowledge is obligatory on every Muslim" (Ibn Majeh, 1952, 1/81, H. 224), he has pushed men and women towards acquiring knowledge and learning science. This hadith cannot only encourage men to learn because the subject of learning is general, and it is not addressed only to men or women but includes both the spectrum of human beings and followers of Islam. The word science in this hadith also has a general meaning; the monopoly of teaching science to religious sciences is an attack on science and opposition to Islam because the Holy Quran and the Prophet did not differentiate between religious sciences and worldly sciences. A true Muslim considers all life religious and all sciences under the umbrella of religious sciences. Islamic teachings specify that a Muslim has more experience and knowledge of life, he is a person who is aware of the truths of religion and can solve all the problems of Islamic society in light of his knowledge (Bikthal, 2021, 174).

After migrating to Medina, the Prophet started building a building that was used for various religious, political, and educational activities. This building was a mosque. The Prophet first built the Quba Mosque and later the Prophet's Mosque. With the construction of the mosque, the ground for various devotional, political, educational activities and science education became an encouraging aspect. Different social strata were mobilized for education and spontaneously moved towards education. Men were not alone in this spontaneous scientific movement, women also played a major role in the pursuit of knowledge, until in Sahih Bukhari, quoting Abu Saeed Khodri from the Prophet, women asked the Prophet to allocate a specific day for their education, because most of the time men came to the presence of the Prophet to learn, they took more time, and they could not benefit from the presence of the Prophet; The Prophet accepted the women's request and allocated one day of the week for their education and preaching (Al-Bukhari, 1422, 1/32).

In this way, the education of women began, the Prophet named one of the gates of the mosque after women. Only women could travel through it. The number of women who learned to read and write became half the number of men. Among the Prophet's wives, people like Hafsa acquired the ability to read and write. Ayesha and Umm Salma, although they

could not write, could read. Among the female companions Karima bint Miqdad wrote and read, Ayesha bint Saad and Umm Kulthum bint Uqbah learned to write from their fathers (Al-Jabri, 1414, 61).

Other literate women of the Prophet's era include Umm Jamil bint Majalal bin Abdullah bin Qays, the wife of Hatib bin Harith bin Mughirah, who was a virtuous and literate woman, Umm Ra'ala Qashiriyah, who was a scholar, poet and eloquent, Nasiba bint Al Harith Umm Atiya, who often She was busy treating the wounded in war, Mu'aza Ghaffariyyah, who was a scholar and scholar contemporary to the Prophet and treated the wounded in war, Umm Hakeem Baida bint Abd al-Muttalib and Umm Rasoolullah, who was a virtuous and scholarly woman, also had a poetic nature, Umm Darda Hajiya bint Ji and Umm Darda Khairah bint Abuhdard Salimah, who were both wives of Abu Darda Amer bin Harith, Arvi daughter of Harith bin Abdulmutallib, Umm Sinan and others were among the graduates of the Prophetic era who were full of grace and knowledge. The education of women had progressed to such an extent that they participated in the propagation of Islam along with men. Among the educated women, Umm Darda was a female jurist and a well-known scholar. According to Nawi, the scholars agreed on Darda's jurisprudence, knowledge, and understanding. She lived in Jerusalem for six months and in Damascus for another six months (Nawi, Bita, 360/2).

The literate women of the Prophetic era are not only limited to these few examples, but there are many examples of Arab Muslim women who learned to read and write. They not only learned, but also taught others, and in some areas, they were even more famous than men they were.

4-2 In the teaching section

Women were not limited only to the field of education but also served in various fields such as teaching, medicine, judging, public duties, civil services, and other social duties alongside men. In the mentioned fields, they worked with dignity and dignity, and in some cases, they had achieved superiority over men (Al-Jabri, 1414, 67).

Many of these women were attracted to educational and teaching affairs, whose names have been mentioned by Islamic historians and their number is up to eighty. Ibn Khalqan mentioned the names of many of these women who were famous for learning science and giving lectures. There are many names of Arab Muslim women in history who taught their profession. In addition to women, men also learned science from them and took permission to teach and narrate from them. Among these women, we can mention Umm Al-Mowayd Zainab, the teacher of Ibn Khalqan, Ibn Khalqan considered her a famous scholar who was narrated by some scholars. And they received permission to narrate. Ibn Khalqan also received permission from him to narrate (Ibn Khalqan, Bita, 2/344-345).

Fakhr al-Nisa Shahida, who had beautiful handwriting. Many people learned science from her until she became famous. Seyyedah Nafsia bint Abi Muhammad. Another women teacher who had a science education council in Egypt, when Muhammad bin Idris Shafi'i, the head of the Shafi'i sect, went to Egypt. He sat in his lesson and heard the prophetic hadith from him. Monsa al-Ayoubiyya, the sister of Malik Adel Salah al-Din Ayyubi, Shamiya bint al-Hafiz, and Zainab daughter Abdul Latif, all three of Ibn Hayyan's famous commentators and grammarians, are among the women teachers. Martyr Katib bint Al-Abri, who had beautiful handwriting and was a master of hadith, recited Sahih Bukhari by Abd al-Rahman bin Dawud in her presence, young and old used to participate in her assembly (Ibn Khalqan, *Bitā*, 2/478).

Ibn al-Mutaraf's prosody, who learned syntax, language and prosody from his master, memorized Al-Kamal Mubard and Abi Ali Qali's *Kitab al-Nawadr*, taught others, and Abu Dawud Sulaiman learned the science of prosody from him (Al-Jabri, 1414, 68); And dozens of other examples in the history of Islam who have taken over teaching positions and in this way have served humanity.

4-3 In the literature section, hadith narration, and Fatwa

During the Prophetic era, many women participated in the fields of writing texts and narrations of hadith alongside men. They taught writing and listening to narrations from the Prophet side by side with men, then they contributed to its dissemination and expansion, which is mentioned below.

A- Writing the Quran: Among the women who had copies of the Qur'an, we can mention Fatima daughter Nabi Akram, Hafsa, the wife of the Prophet, and Umm Warqa, who had copies of the Qur'an. Although there is little evidence about the Mushaf of Fatimah, daughter of our Prophet, that she had a Quranic Mushaf, considering the upbringing she had in the lap of the Prophet's family and the love of the Qur'an, this possibility does not seem unlikely. However, some consider Hazrat Fatima's Mushaf not a Quranic version, but as proverbs, advice, sermons, instructive words, and news (Ramiar, 1369, 338).

Hafsa had a copy of the Quran. This Mushaf is different from the Mushaf that was collected during the caliphate of Abu Bakr and was with him after the caliphate of Umar, until he took it from him in the era of the third caliph Uthman, compiled the Qur'an and used it, and handed it over to him again (ibid, 385) According to Al-Siyuti, Umm Warqa, the daughter of Abdullah bin Harith, who was killed during the caliphate of Umar, had a copy of the Quran, although others, except Siyuti, did not say anything about her copy (ibid, 340).

B- Narration of Hadith: At the beginning of Islam, many women narrated Prophetic Hadith, which cannot be mentioned in this article. Here, only the Prophet's wives who narrated hadith from him have been mentioned. The wives of the Prophet who narrated the

hadith and have narrations from the Prophet are Aisha, Umm Salma, Hafsa, Safiya, and Soudah, whose narrations are mentioned in Sunni sources. Among the Prophet's wives, Aisha is at the top in terms of the number of narrations. The elders of the Companions used to ask him about the rituals and many of the rules of the religion, and he would answer them intelligently. Ayesha narrated two thousand two hundred and ten hadith from the Prophet (Al-Jamaili, 1416, 44).

Umm Salma, Hind Daughter Suhail was the most understanding, wise, and moral wife of the Prophet. He did not interfere in politics like Ayesha but was far away from it. When he heard that Ayesha had gone to Jamel, he wrote a letter to her and forbade her to go. Umm Salma narrated a total of 378 hadiths from the Prophet (ibid, 84 and 89). Other wives of the Prophet who had a hadith narrated by him include Hafsa Dautgher Umar al-Khattab, 60 hadith (ibid, 70). Safiya bint Hay Akhtab has ten hadith (ibid, 115) and Soudah Daughter Zam'ah has two hadiths (ibid, 41) that have been narrated from the Prophet in Sunni sources. This is even though, apart from the Prophet's wives, many women such as Asma Dautgher Abu Bakr, Noura Daughter Malik bin Sarma, Asma Dautgher Umair, and others have narrations about the Prophet in Shia and Sunni hadith sources, which were refrained from being mentioned for the sake of length.

C- Fatwa: Ibn Qayyim has divided the scholars and muftis of the Companions into three categories according to the number of their fatwas, those who gave the most fatwas, those who were in the middle, and others who gave the fewest fatwas. In the group of the most, which counted one hundred and thirty people, most of the fatwas were given by Omar Ibn Al-Khattab, Ali Ibn Abi Talib, Abdullah Ibn Masoud, Ayesha, Zayd Ibn Thabit, Abdullah Ibn Omar, and Abdullah Ibn Abbas; That is, Aisha's fatwa is among the most numerous women. In the middle group, in addition to some male companions, there is Umm Salma, and in the smallest group, there are women, such as Umm Atiya, Safiya, Hafsa and Habiba. Ayesha gave fatwas during the caliphate of the Rashidun caliphs and obtained this position after the death of the Prophet. He had become the authority of the questioners and continued to do so as long as he was alive. Umar and Uthman used to send someone to him and ask him about the Sunna of the Prophet (Al-Hosseini, 1424, 327).

5- In the poetic and literary

These sections were very important among Arab people. Before Islam, the Arabs held an Olympiad of poetry in Akaz Bazaar and wrote the best of them with water-gold on a striped piece of white linen and hung it on the wall of the Kaaba. Sometimes the tenth is famous (Al-Gholaini, Bit, 14). Women also participate in this activity. After the invitation to Islam, poetry writing continued among Muslims, especially women, with the approval of the Messenger of Allah, and women such as al-Khansa continued to write poetry. Muslims were prohibited from writing poetry in cases that were against the principles of Islam or caused persecution of the Prophet. The writing of poetry and poetry continued not only with the

approval of the Prophet, but also with the encouragement of His Holiness, and capable poets were encouraged by His Holiness. Khansaa sang a poem in the presence of the Prophet, the Prophet encouraged her to write other poems as well, the encouragement of the Prophet was extremely influential for poets, especially women poets, until women poets used poetry to encourage men and encourage them to jihad through poetry (AlZarkali, 2002, 2/86) In addition to encouraging Jihad, Maimouna bint Abdullah cursed those who wept for their dead in the Battle of Badr, Athazah bint Aban responded to the poems of India that she had written to encourage the infidels to fight in the battle of Uhud (Ahmadi, Hashemi 2018, 52) Khansaa encouraged the Muslims to fight with the enemies by writing poetry in the Qadisiyah war, and a poetry divan is also remembered from him (Al-Zarkali, 2002, 2/86).

The poetic purposes of women and men are almost the same and include things such as praise, satire, lamentation, sonnet, boasting, etc. except that women had the upper hand in some poetic purposes and men in others; But what most women had the skill and superiority over men was elegies and persuasion and encouragement for war and jihad. The contribution of women in encouraging and persuading men to war and jihad was mentioned above. Women in Ratha have also overtaken men as encouragement and persuasion. Female poets from the time of the Prophet to the bloody wars that happened between Muslims wrote elegies and contributed. There are many lamentations in poetry. Safiya, the Prophet's aunt, was one of the women who wrote poetry in mourning for her father, her brother Hamza, and the Prophet (Ghanmi, Saadounzadeh, Sephiyar 1391, 35).

6- In medical and military departments

Women were present alongside men in medical and military work, although basic jihad is not obligatory for Muslim women. Muslim women on war fronts, in addition to treating the wounded, were also responsible for logistics and sometimes defense issues, which are many examples of such activities in the early days of Islam.

6-1 In the medical sector

The medical institution was not widespread among the people due to the primitive nature of the Arab people and their lack of urbanization. But since humans cannot be safe from pests and diseases, on the other hand, the continuous wars that raged among different Arab tribes before Islam made some of the most prominent men experienced in treating diseases and war wounds. During the Prophet's time, medical institutions continued in the same state as before. In addition, men and women treated the war wounded and treated the sick. Among the women who accompanied the Prophet in wars and treated the wounded, we can mention Rafidah, who had a healing tent (Ibn Abd al-Barr, 1838/4/1412).

Many women were busy treating the war wounded, which was confirmed and encouraged by the Prophet, who prayed for them. Among them is Kaabiyyah bint Asad al-Aslamiya, who was a famous doctor like Rafidah and was present in wars including Khyber (ibid, 4/1907). Fatemeh al-Zahra, daughter of the Prophet, is also among those who, in addition to providing logistical aid to the front, has given treatment to the war wounded. If he treated the injuries inflicted on the Holy Prophet in the battle of Uhud with the help of Ali (Al-Bukhari, 1422, 5/101). Bukhari also narrated from Rabi' Bint Mu'adh, who said, "We used to accompany the Prophet in wars, give water to the people, treat the wounded, and transport the martyrs to Madinah" (ibid, 34/4).

6-2 In the military sector

Although the first jihad is not mandatory for women, women participate in the fronts of jihad to support the army, and provide logistical work, guard, and other services. The most important work of women on jihad fronts has been to encourage fighting, support, and supplies, and, if necessary, jihad against enemies.

A- Encouraging to fight: Encouraging to fight is a divine command that is addressed in verse 65 of Surah Anfal, "O Prophet, encourage the believers to fight. Women played a major role in this matter, as in the battle of Uhud, when the Muslims were defeated, Safia, the Prophet's aunt, And Umm Ayman rushed to the battle scene and encouraged the Muslim fugitives to fight by saying words (Waqadi, 1409, 1/288). In Hanin's campaign, when the signs of defeat in the Muslim army appeared, Shaddam al-Harith Ansariyyah and Umm Amara encouraged the fugitives to jihad (ibid, 904/3).

B- Procurement activities: Another activity of women was the procurement of war fronts. Such activities as recruiting soldiers, preparing food, maintaining and collecting arrows and weapons that were scattered in the battle scenes, helping the wounded, and transporting them to a safe environment were among these activities. Umm, Salim! Bint Melhan and Ayesha bint Abu Bakr carried water bottles on their backs during the battle of Uhud (Al-Bukhari, 1422, 4/33). There were many women from Muhajir and Ansar, such as Hamna bint Jahsh, Umm Atiya Ansari, Barkah bint Thaalba, Samira bint Qais Ansari, Umm Ziyad al-Ashjayeh and others, who provided logistical services for Muslim fighters.

C- Direct struggle: Since women have participated in various activities behind the front, it is natural that they have fought directly against the enemies of Islam when necessary, and have defended the integrity and honor of Islam. Umm, Salim! Bint Melhan is one of these people. He, who was carrying a dagger with him in the battle of Hanin, was asked by the Prophet, and he replied that I had taken it with me so that if an enemy met me, I could cut his stomach. Also, she is one of the first women who boarded a warship with her husband for Jihad (Al-Bukhari, 1422, 4/33). Umm, Amara, fought in Uhud to support the Prophet against the polytheists and received major wounds. Safiya bint Abdulmutallib also attacked and

killed a Jewish person in the Battle of Khandaq, who had the aim of scaring and harassing Muslim women. In the battle of Hanin, Umm Amara attacked the enemies with a sword and Umm Salim with a dagger, and other women also started fighting when the Muslims were defeated (Jalali Kandari, 1382, 113-115).

7- In the political, social, and economic sectors

Women in Sadr Islam have had extensive activities in these sectors as well. If the Prophet's pledge of allegiance to women, which is mentioned in the verses of the Quran, somehow shows the participation of women in politics, and Khadija's business shows the economic activity of women at the top of Islam.

7-1 Social political section

In the twelfth verse of Surah Mومتahناه, the Quran has commissioned the Prophet to swear allegiance to Muslim women. According to this Quranic ruling, the Prophet pledged allegiance to Muslim women, especially Quraysh women who had recently converted to Islam, and by doing so, he somehow established women's participation in political affairs. According to this article, women at the beginning of Islam played an active role in political and social affairs, women's activities were widespread in various sectors, in the social and political sectors in the twelfth and thirteenth years of the Prophethood, it is also well seen, in the pledge of allegiance of the people of Medina to the Holy Prophet In Islam, which is called the first and second Aqaba, women were also present (Ibn Athir 1417, 1/690).

according to the content of the pledge of allegiance to the Prophet, in which obedience to the Prophet of God was in various states and declaration of adherence to religious orders, many women such as Asma Bint Abu Bakr, Asma bint Umis, Umm Salim Khazraj, Umm Ayman bint Thaalbah bin Amr, Umm Ayyub, Umm Haram bint Melhan, Umm Sinan al-Aslamiya, Umm Mubasher bint Bara bin Mawar Ansari, Umm Hisham Ansari, Amina bint Mohsan Asadi, Khansaa bint Khaddam, Khula bint Qais Ansari, Zainab Thaqifa, Soudah bint Zamah, Safia bint Abdul Muttalib, Rabia daughter of Mu'adh Ansari, Hind wife of Abu Sufyan and a group of Mecca women have pledged allegiance to the Prophet. The verses and historical reports of the Prophet's pledge of allegiance and giving them a share in social affairs show that at the beginning of Islam, women participated side by side with men in important social and political affairs (Gharavi Naini, 2008, 6).

7-2 Economic Sector

The Holy Quran has left women as free as men in economic affairs to obtain and enjoy the benefits of their economic activities within the framework of divine laws. The Quran says, "For men, there is benefit from what they have earned through their activity, and for women, there is benefit from what they have earned through their efforts" (Holy Quran, verse 32 of

Nisa). This is even though they have already considered the right of inheritance for women and institutionalized it: "For men, it is a share of what is left from their parents and relatives, and for women, it is a share of what they leave behind" (Holy Qur'an, Verse 7 of Nisa).

Conclusion

According to the history of the beginning of Islam and the activities of Muslim men, with the presence of the Holy Prophet at the beginning of Islam and the approval of women's activities by him, the following result has been obtained.

Women are present at the forefront of Islam in all cultural and social fields, even in military activities and fighting against the enemies of Islam. While Jihad is not mandatory for them, they are also present in case of necessity.

The Prophet's wives at different stages of their lives, by taking part in various cultural and socio-political activities, have not only performed various tasks, but their activities in various fields of life have paved the way for the social and cultural activities of Muslim women throughout history.

After the establishment of the Islamic government and the establishment of Masjid al-Nabi in Madinah, different classes of people, including men and women, turned to learning knowledge, and there was no shortage of men in this field. Some women were allowed to teach other women, and others requested the Prophet to dedicate one day of the week to teaching in the presence of the Holy Prophet.

Many women, like al-Khansa, turned to the language of poetry in writing poetry and defending the Holy Prophet. Those who considered the new orders of Islam for various poetic purposes impressed the Prophet and encouraged him to compose poetry.

In addition to educational activities, women were also engaged in teaching, jurisprudence, fatwa, narrating narrations, writing, and medical services. Examples of such people include Umm Salma, Ayesha, Umm Darda, Rafidah am Salim.

Therapeutic activities, logistics, and even military confrontation with the enemy in case of necessity are other activities that were presented to the Islamic army by Muslim women at the forefront of Islam. In many wars, women have been responsible for providing water, feeding, treating the wounded, transporting the bodies of martyrs to the city of Medina, guarding the army, and even direct defense.

The women of Sadr Islam were involved in various social, economic, and political activities, such as the economic activities of Khadija Al-Kabri, who was a successful businessperson, women's pledge of allegiance to the Prophet in Aqaba, Hudaibiyah, and Mecca, and engaging in social work are among those activities.

According to the range of social and cultural activities of women in Islam, it can be said that there was no prohibition on women in any field of social activities promoted by Islam.

Döyüş səhnələrində olan qadınlar, düşməne qarşı vuruşmağa təşviq edilməklə yanaşı, orduya yemək və su vermək, yaralıları müalicə etmək, lazım gələrsə, İslam düşmənləri ilə üz-üzə döyüşmək kimi maddi-texniki fəaliyyətlərlə də məşğul olmuşlar. Peyğəmbərin zövcələri arasında Xədicə kimi insanlardan Peyğəmbərə bütün gücləri ilə dəstək olmaları istənilirdi. Женщины, как и мужчины, являются членами общества и обязаны подчиняться заповедям Божиим. Членство в обществе налагало на женщин обязательства, а в некоторых случаях требовало от них участия в общественной деятельности наравне с мужчинами. На ранних этапах распространения Ислама Некоторые женщины учились вместе с мужчинами, писали книги, обучали грамоте, пересказывали пророческие хадисы, юриспруденцию и даже фетвы, а также писали стихи в защиту ислама и Пророка (мир ему и благословение Аллаха).

Помимо поощрения к борьбе с врагом, женщины на полях сражений также занимались материально-технической деятельностью, такой как снабжение армии продовольствием и водой, лечение раненых и, при необходимости, сражение с врагами Ислама лицом к лицу. Среди жен Пророка таких людей, как Хадиджа, просили поддерживать Пророка изо всех сил. Хафса способствовала написанию Корана, а Умм Сальма и Аиша изучали Коран и передавали множество хадисов Пророка.

Следы женщин отчетливо видны в различной социальной, культурной и политической деятельности Садр Ислама. Вы не найдете ни одного места без их присутствия. Для женщин не было никаких препятствий в сфере образования, работы, социальной и культурной деятельности.
