INVESTIGATION OF PERSONALITY CHARACTERISTICS AND INTERNET ADDICTION IN ADOLESCENTS

Introduction

In the 21st century, also called as information age, computer and internet engaged in our every field of life. While the information technologies first developed for easing the life brings not only benefits but also problems with itself. Internet addiction is one of these problems. Since adolescents have much interest on technology they use the internet much more than other age groups. Therefore, since the cognitive, emotional and social development processes have no end adolescents are under danger of internet in terms of its negative effects (Yang & Tung, 2007). Researchers use the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders criteria and in the frame of these criteria they benefited from sex addiction, pathologic gambling and other behavior addictions (Thurlow Lengel & Tomic 2004).

According to Young, who put forward internet addiction for the first time and formed the first diagnosis criteria, internet creates an addiction like gambling and internet addicted people show different impulse control disorder symptoms (Greenfield, 1999). Internet addiction is defined as a subset of a technological and behavioral addiction (Griffith, 1998). Generally, internet addiction is defined as "wasting excremental time on the internet problem" (Young, 1996).

One of the main reasons for the emergence of internet usage as an addiction type is the "usage amount" or the amount of time spent in the on-line media (Chou, Condron & Belland, 2005). Spending a long time on the Internet can be considered both a symptom and a result of both of the reasons of internet

addiction (Irwansyah, 2005). The reason for this is daily or weekly internet usage periods of addicted users in researches are higher than non-addicted users (Cao &

Su, 2007). The only criteria for determining internet addicted is not only the time spent on the internet; It also carries great importance for the time that is spent for what purpose. The probable positive and negative consequences of internet usage are directly related to the reasons and purposes of internet usage. Users who are addicted to the Internet, while they spend much more time on movie-music sites, play sites, chat rooms, pornographic sites, social sharing sites and etc sites (Murali & George, 2007; non-internet users spend time on news, shopping and educational sites (Kim & Kim 2002).

When moved upon by the data that individuals use the internet to satisfy their information, communication and entertainment needs; The relationship between the use of the internet and personality characteristics are naturally coming to forefront. Personality characteristics affect motivation and behavior related to social interaction. When studies considered that examine the relationship between internet addiction and personality characteristics, it is seen that the subject is gathered around two views, which are opposite to each other. One of them is "Social Network Theory". This theory argues that personality characteristics are the most important determinant of motivation and behavior, especially in social interaction. Extroverted individuals enjoy starting social interaction, and are particularly successful in this interaction than introverted individuals. Neurotic individuals are individuals who are quite sensitive to anxious, hyperactive, and social stimulants, and are more likely to fail in social interaction than balanced individuals (Martinez & Thomas, 2005). This theory defends that the internet is primarily beneficial to extroverts. It is stated that extroverted individuals are in more need of communication than introverted individuals, and therefore they use the internet mostly for interactivity (Kraut, Kiesler, Boneva, Cummings, Helgeson & Crawford 2002). The hypothesis of social compensation suggests that internet is more beneficial to introverted individuals (McKenna & Bargh, 2000). The studies based on this hypothesis argue that individuals increase their self-disclosure behavior online, since being anonymous on the internet and hiding someone's identity reduces the anxiety of rejection and mocking of the introverted individual (Ehrenberg, 2008). When this information is taken into account, relationship between personality and internet usage; it is clearly seen that it is handled in the context of personality and social interaction. In the studies that the personaliy characteristics are researched there are positive relationships mentioned between dimensions of "extroversion" (Kraut, 2002), "introversion" (McKenna & Bargh, 2000), "neurotic" (Hamburger & Ben Artzi, 2000) and "openness to experience" (Tuten & Bosnjak, 2001) and internet addiction. Openness to experience is associated with the use of the internet for entertainment and information production, whereas neuroticism is generally negatively associated with internet use (Tuten & Bosnjak, 2001). Individuals whose responsibility are dominant they are regular and self-disciplined individuals. These individuals undertake the responsibility of the

relationship they establish and do not have any difficulty in maintaining it. These features enable individuals to concentrate more on the actual connections and activities than on the internet. Individuals whose emotional imbalance is predominant may prefer the internet where they can easily manipulate relations and conditions rather than direct relationships because they are insecure, anxious and nervous about relationships (McCrae & Costa, 1991).

Researchers conducted on internet addiction have increased especially in recent years. The most important reason for this is the internet can be shown as a factor causing some serious problems especially on adolescents. It is thought that the examination of this situation is important because the problems that arise in the adolescents threaten the current day and the tomorrow of the society.

Method

The population of this research conducted in accordance with the relational screening model is composed of students who study at Kayseri High Schools. The sample of the research comprises 246 male (55%) and 206 (45%) female students, 452 students totally, selected among adolescent students with the random sampling method.

Data collecting tools

1. Internet addiction scale

The Internet Addiction Scale developed by Gündüz & Kayri (2009) was used in the study. The scale development sample is composed of 754 secondary school students. It is a 5-point Likert type, 35-item scale. The "Two-Stage Clustering Analysis", which is a classification method, was applied for the scoring of the scale to obtain more detailed information about addiction status of the individuals. Cronbach's alpha (α) internal consistency coefficient of the scale was calculated as .944. The exploratory factor analysis was used for structure validity, and the confirmatory factor analysis was chosen to test the accuracy of the factor structure obtained. The scale is composed of four subfactors: Deprivation (IAD), Control Disorder (IDCD), Functional Deterioration (IDFD), and Social Isolation (IDS). Total explained variance for the scale was found to be 47.463%.

2. Five factor personality scale

The scale which was developed by Benet- Martinez & John (1998), translated to the Turkish and used in a intercultural study by Sümer, Lajunen and Özkan (2005) measure the five personality factor effectively. Scale used in the research consisted of 44 questions and it is used as five point likert type. Dimensions of the used scale; **Extroversion** and **Emotional imbalance** are 8,

Responsibility and **Adaptability** are 9 and **Openness to Experience** is consisted of 10 articles.

High scores that are acquired from each sub scale show that individual exhibit that personality characteristic at a high level. In the conducted study for the Turkish sampling for the sub scales the Cronbach alpha values change between .64 and .77 (Sümer et al., 2005). In this research for the sampling group the Cronbach alpha values; Extroversion (.74), Responsibility (.73), Adaptability (.62), Openness to Experience (.73) and Emotional Imbalance (.67) it changes between .62- .74.

Analysis of data

The data obtained in the research were analyzed with Pearson's Product Moment Correlation Coefficient to see the relationship between variables and the Multiple Regression Analysis to identify the variables that predict internet addicted.

In the Table 1 the relationship between internet addiction and personality characteristics scale sub dimesnions were examined. There was a positive and meaningful relationship found between deprivation and control disorder ($r = .294$ $p < .000$), deprivation and functional disorder ($r = .722$ $p < .000$), Deprivation and social isolation ($r = .392$ $p < .000$), deprivation and adaptability ($r = .294$ $p < .000$), control disorder and functional disorder ($r = .732$ $p < .000$), control disorder and social isolation ($r = .248$ $p < .000$), control disorder and responsibility ($r = .034$ $p < .000$), control disorder and adaptability ($r = .732$ $p < .000$), social isolation and functional disorder ($r = .477$ $p < .000$), extroversion and responsiblity ($r = .543$ $p < .000$), extroversion and adaptability ($r = .571$ $p < .000$), responsiblity and adaptability ($r = .658$ $p < .000$), responsiblity and openness to experience ($r = .593$ $p < .000$), openness to experience and adaptability ($r = .705$ $p < .000$).

There was no meaningful relationship found between deprivation and openness to experience ($r = -.057$ $p < .348$), control disorder and extroversion ($r = -.053$ $p < .381$), control disorder and openness to experience ($r = -.035$ $p < .566$), functional disorder and extroversion ($r = -.101$ $p < .093$), functional disorder and adaptability ($r = -.057$ $p < .342$), functional disorder and openness to experience ($r = -.084$ $p < .164$).

There was a negative and meaningful relationship found between deprivation and responsibility ($r = -.071$ $p < .000$), deprivation and emotional imbalance ($r = -.069$ $p < .000$), control disorder and emotional imbalance ($r = -.040$ $p < .000$), functional disorder and responsibility ($r = -.840$ $p < .012$), functional disorer and emotional imbalance ($r = -.043$ $p < .002$), social isolation and openness to experience ($r = -.055$ $p < .000$), social isolation and emotional imbalance ($r = -.046$ $p < .000$), extroversion and emotional imbalance ($r = -.502$ $p < .000$), responsibility and emotional imbalance ($r = -.577$ $p < .000$), adaptability and emotional imbalance ($r = -.595$ $p < .000$), openness to experience and emotional imbalance ($r = -.537$ $p < .000$).

Datum related to multiple regression analysis related to prediction of internet addiciton in adolescents in the Table 2.

In the Table 2 multiple regression analysis results of personality characteristics and internet addiction sub dimensions were given. When dual and partial correlation values between dependent and independent variances there was no meaningful relationship found between internet addiction and extroversion ($t=,988$ $p<,001$), internet addiction and adaptability ($t=-1,384$ $p<,001$), internet addiction and openness to experience ($t=,453$ $p<,001$) internet addiction and emotional imbalance ($t=-,383$ $p<,001$).

While there was a negative correlation found between control difficulty and internet addiction ($r=,294$) when other variances taken under control the correlation between control difficulty and internet addiction found as $r= -,187$. It is seen that there was a negative correlation between responsiblity and internet addiction ($r=-,091$). When other variances were taken under control the correlation between responsibility and internet addiciton was guessed as $r= -,084$. There was positive correlation between functional disorder and internet addiction ($r=,743$). When other variances were taken under control the correlation between functional disorer and internet addiction was guessed as $r= ,722$ olarak.

When multiple regression analysis results related to prediction of internet addiction in adolescents there was a meaningful realtionshp found between functional disorer, responsiblity and control difficulty ($R=,802$, $R^2= 0,643$, $p<.001$). With the mentioned four variances it explains aproximately 6% of the total variance of internet adiction in adolescents.

According to standardized regression coefficient (β), the reasonable importance order of predictor variances on internet addiction; functional disorer ($\beta=,487$) social isolation ($\beta=-,005$), responsibility ($\beta=-,148$) and control disorder ($\beta=-,679$). The t-test results related to meaningfulness of regression efficiencies extroversion, openness to experience, adaptability and emotional imbalance are not predictor in internet addiction.

Result and discussion

According to findings of the research when internet addiction and personality characteristic scales sub dimension were examined there was a positive and meaningful relationship found between deprivation and control difficulty, deprivation and functional disorder, deprivation and adaptability, control disorder and functional disorder, control disorder and social isolation, control disorder and responsibility, control disorder and adaptability, social isolation and functional disorder, extroversion and responsibility, extroversion and adaptability, responsibility and adaptability, responsibility and openness to experience, openness to experience and adaptability. And also there was a

negative and meaningful relationship found between deprivation and responsibility, deprivation and emotional imbalance, control disorder and emotional imbalance, functional disorder and responsibility, functional disorder and emotional imbalance, social isolation and openness to experience, social isolation and emotional imbalance, extroversion and emotional imbalance, responsibility and emotional imbalance, adaptability and emotional imbalance, openness to experience and emotional imbalance. It is seen that relationship between personality and internet usage; it was dealt in the context of personality and social interaction. In a study that five factor used, there was a relationship between "openness to experience", "neuroticism" characteristics and internet usage. While openness to experience has a relationship with usage of internet in terms of fun and information production, generally neuroticism has a negative relationship with internet usage (Tuten & Bosnjak, 2001). It is determined that personality characteristics predict the internet addiction (Ko, Yen, Chen, Chen, Wu, & Yen, 2006). In another study which personality characteristics used internet addicted people are considered as self confident, like to do activities alone and avoid from social activities (Young & Rodgers, 1998). There are also studies that determine there is no relationship between personality characteristics and internet usage (Engelberg & Sjöberg, 2004).

When multiple regression analysis results were examined related to prediction of internet addiction in adolescents there is a meaningful relationship between functional disorder, responsibility and control difficulty ($R=.802$, $R^2=0,643$, $p<.001$). With the mentioned four variances it explains approximately 6 % of total variance in internet addiction in adolescents. According to standardized regression coefficients (β), relative importance order of predictor variances on the internet addiction; functional disorder ($\beta=.487$) social isolation ($\beta=-.005$), responsibility ($\beta=-.148$) and control disorder ($\beta=-.679$). When t-test results were examined related to meaningfulness of regression coefficients; extroversion, openness to experience, adaptability and emotional imbalance are not predictor on the internet addiction. It is determined that personality characteristics do not predict internet addiction (Ko, Yen, Chen & all., 2006). Müller, Koch, Dickenhorst, Beutel, & Duven, (2013) also determined that there was a negative and meaningful relationship between personality characteristics and internet addiction. When another study was examined relationship between internet addiction and personality characteristics; it was determined that emotional balance is at the low level on the individuals with high level of internet addiction, that is, this dimension predicts the internet addiction in the negative aspect (Yang, Choe, Baity, Lee & Cho 2005).

In the studies that the personality characteristics are researched there are positive relationships mentioned between dimensions of "extroversion" (Kraut et

al., 2002), "introversion" (McKenna and Bargh, 2000), "neurotic" (Hamburger & Ben Artzi, 2000) and "openness to experience" (Tuten & Bosnjak, 2001) and internet addiction. Openness to experience is associated with the use of the internet for entertainment and information production, whereas neuroticism is generally negatively associated with internet use (Tuten & Bosnjak, 2001). Individuals whose responsibility are dominant they are regular and self-disciplined individuals. These individuals undertake the responsibility of the relationship they establish and do not have any difficulty in maintaining it. Suggestions

1- there should be studies done for the increase of awareness related to internet addiction and also training studies done for the conscious and reliable using of the internet for families, children and adolescents.

2- It will be effective for the internet addiction and personality development when school counseling service determine the risky adolescents and giving them preventive counseling service.

3- Personality of the students will be positively effected when school counseling service determine the poor students and giving them group counseling for their socializing.
