Bu işin məqsədi təşkilati öhdəlik anlayışına dair konseptual çərçivəyə diqqət çəkməkdir. Təşkilati öhdəlik tədqiqatları araşdırıldıqda, konsepsiyanın nəzəri quruluşu yaradılmağa çalışılır. Tədqiqatın araşdırıldığı zaman fərdlər , təşkilatlar üçün əhəmiyyətli görünən mənəvi sabitlik, davamlılıq və normativ öhdəlik kimi tanınan üç sub-ölçüdə ibarət olan təşkilati öhdəlik fərdi və təşkilatlar üçün uyğun araşdırma aparıldıqda vacib bir element kimi ortaya çıxır. Cins, yaş, təhsil müddəti, təhsil, təşkilati struktur, əmək haqqı, iş keyfiyyəti, idarəetmə strukturu və peşəkarlıq kimi fərdi xüsusiyyətlər təşkilati sadıqlıya azaldıcı və ya inkişaf edən təsir göstərir. Bu araşdırmada audit mərkəzi uyğun ədəbiyyat vasitəsi ilə yoxlanılmışdır. Uyğun ədəbiyyat üzrə aparılan araşdırmada təşkilati öhdəliyin vacibliyi müəyyənləşdirilmişdir.

РЕЗЮМЕ

CONTRIBUTION OF THE CITIZENS TO IMPROVE MUNICIPAL MANAGEMENT

1. Introduction

Local government units which are in closest public relations in public administration. In recent years, the winds of change began to blow in local government structures and local economic diversification efforts with the observed local government, strategies to support the improvement of the public have begun to develop the services they offer. Local governments are institutions established for the purpose of fulfilling the wishes and needs of local people. One important point to note, provided that they could be able to measure the degree of satisfaction of the people in the fulfillment of these services and corrective - developing preventive action, citizen-centric service delivery can be carried out.

In social life, to win the people's trust and support for municipalities, public institutions are more important than the other. Therefore, to treat sensitive to people's needs and aspirations, people's continued support to ensure the appreciation and trust are important to municipal governments. To ensure efficiency in service production and local governments pledging to meet over the public needs are local in nature, the world and the establishment rationale and objectives in Turkey has shown similar characteristics is to meet the maximum of people need basic purposes.

In this study, in terms of municipalities, opinions of municipalities where population is connected to, determination of management perception and service quality satisfaction or dissatisfaction, it will have benefits in terms of guidance to decision makers of municipalities in increasing or changing the nature of the

service being considered. At the same time questioning the opinion of those who benefit from the service in terms of public utility services and the analysis of the current situation is expected to benefit in terms of reviews.

2. Municipal management services

The local government created to meet the local quality needs of the local people, the first time only when the efforts to provide a scheme in order to sustain my daily urban life, changing over time and in proportion to the demands imposed by emerging life local authorities, regulation of physical spaces, health, social welfare, environmental issues they had also forced to assume various responsibilities in matters (Berk, 2003).

This is dependent on the administrative and financial aspects of the center to carry out the responsibilities that they undertake these methods are directed to alternative methods of supply of services (Neyiz, 2007).

2. 1. Procurement Method

With current 4734 Law on Public Procurement, the apartments included in the general budget, annexed budget administrations, provincial purchases of private administrations and municipalities, sales, service, construction, rent, in and taking jobs such as moving to the private sector through tenders possible, and development plans, this method is encouraged (Akcan, 2006).

The most important benefit of the tender process, which makes it possible to benefit from competition. Thus, a competition is concerned in terms of cost and quality among competitors to win the contract. This is the basic point that improves the efficiency of the related public services. The other permanent members of the temporary service can be carried out without the benefit of employment. It can also benefit from the non-qualified personnel on their staff. What is important here is the estimated cost for services will be tendered for regular supervision during the execution of the healthy and performed services (Eken and Eryilmaz, 1990: 62).

However, bribery and favoritism type of application, system damage healthy processing orientation. Bribery between private sector representatives and municipal officials, fully eliminate the positive return of the competition (Acartürk, 2001: 48).

A tendering procedure, garbage collection, street sweeping, parks does not require the employment of qualified staff, such as maintenance and it is seen that the private sector can provide effective delivery of services. This is due to the nature of such services, to reduce the public interest served by the private sector or to increase the public interest is not served the municipality in question. However, the private sector and to reduce the costs of delivering high quality service will get more of his compatriot and argued (Acartürk, 2001: 47).

2. 2. Concession Method

The provision of a public service municipality, the capital, for all expenses, including of the profits and losses of private entrepreneurs, the municipality put that conditions in exchange for privileges and benefits to be provided to establish by private legal persons and exploitation or to transfer only the operation is the norm. Method of granting concessions in the municipality as a monopoly to a privately owned company with a monopoly on a service contract or a geographical region with services of this nature is transferred to the private sector. Concession method usually water, electricity, a method where the natural monopolies such as natural gas. Who benefit from the service, the company won the right to pay the concession fee for the service (Kepenek, 1990: 155).

Who benefit from the service concession system will pay the cost of services the company offers direct service. In this case, it will be difficult to meet by users of the service fee, while engaged in competition as well as the procurement process at the stage of granting concession, the concessionaire in the absence of competition in the next stage of the company may lead to the provision of unjust enrichment (Muter, 1994: 150).

2. 3. Build - Operate - Transfer Method

Build-operate-transfer method, by definition, an investment or services falling within the remit of public investment and businesses during uploaded charges will be made and will be driven by investment in exchange facility, it is a company held hands with the right business over a period of time and the tariff determined in advance (Emek, 1999: 2).

So, in order to provide a public service that requires high finance, capital and bear all risks, including the local and foreign entrepreneurs, the transfer of relevant public institutions, free of charge after using a certain period of time established by the relevant entrepreneurs (Neyiz, 2007: 58).

Make-operate-transfer method is a method used to encourage private entrepreneurs in countries where complete formation of free market economy. The main purpose of some services that require large capital this method is open to foreign capital, especially in countries suffering from capital shortages. Thus, this method also encourages the entry of foreign capital (Ulusoy and Vural, 2003: 10).

Without any financial burden for the public authorities to create his own resources in terms of this method is a kind of concession. Private individuals or the creation of a service unit by people over property owned in the structure of the system, in particular those of operation and expiry of the period specified in the contract as gratuitous the existence of any kind of business to go into public administration is located principles (Eken and Eryilmaz, 1990: 67).

2. 4. Hire Methods

Any business carried on by the municipalities and the private sector to hire a temporary period at a certain price with immovable assets. Business and movable properties belonging to the company, the ownership of immovable assets owned by the municipality. Therefore, the company does not make any specific expense for these assets. A private company that took over the management of tasks in exchange for rent through the municipal company is to produce a public service. Private companies took over the company at the end of the lease term and assets, taken over by the state and in working order is obliged to deliver to the municipality (Akış, 1994: 44,45).

Leases, must be owned by the management of the necessary tools and equipment to carry out the service and the operation is given to private individuals or organizations. This system differs from the concession, the duration of the public that the goods and services necessary investment for leasing is shorter than the concession method. In this way, public institutions, efficient running unable enterprises to take advantage of the private sector in the management and supervision of experience giving them the rent is intended to become more profitable case of public enterprises (Eken and Eryılmaz, 1990: 64).

Leases with municipalities, they could not run profitably and efficiently by transferring the business to the private sector is intended to increase the profitability and efficiency of these enterprises. Municipalities, public bread factory, slaughter facilities, the business of business by renting the private sector, such as asphalt and concrete plants could strengthen economically.

2. 5. Incorporation and Joint Venture

1580 Municipalities with the Law Article 19 of the law of the municipal authorities if they fulfill the tasks assigned to them and be able to set up a company in order to meet the common and civil needs of the people of the town and has allowed them to be able to participate in existing companies. Based on this provision, go to the incorporation of municipal roads. Municipalities need to establish incorporation policy and trade centers in the city, the tourism industry need to realize the needed investments, job opportunities and economic resources were aiming to provide new services such as creating more effective and efficient. Lack of resources and qualified personnel in the municipalities in our country, the main hindrance to perform the tasks assigned to him (Neyiz, 2007: 57).

But here the issue of setting up a company in the municipality need to know, it will not go directly to the company of municipal services. The Company does not impose itself rather than municipalities. Municipal public services to private individuals, blowing a company that wants to establish itself as a partner or must do so within a contract (Ulusoy and Vural, 2003: 11).

The joint venture, established with private sector companies specializing in large-scale investment in public service unit, is the state to realize through partner companies. Here it is essential to create the very partnership agreement (Neyiz, 2007: 57).

2. 6. Sales Methods

The success of privatization, spreading of ownership through stock sales and directing the purchase of privatized public enterprises is one of the main objectives of the local economy. Together with the private sector, the characteristics of units to be sold on the day of transfer of ownership and economic conditions, sales method varies according to the target group of investors received. Privatization IPO, domestic and block sales to foreign capital, of which sales methods, such as corporate supply in the international market to be used, position of the sector in enterprise to be privatized, the technology owner, investment demand, international competition and integration facilities, is directly related to market share and competitive position (Devrim 1994: 25).

Land in the hands of municipal buildings, municipal enterprises and assets of all kinds of "direct sales" or "sales through share" may be subject to sale by model. Assets of public bodies subject to the direct sales model is fully or partially sold. The other model is transferred through all or part of the shares of the public enterprise shares to private individuals or organizations. Such an application can be made, to be divided into shares of the capital of public enterprises to be privatized and must be located in the capital company status (Muter, 1994: 149).

2.7 Method Coupons

Method of pricing of municipal services in the event of coupon no power to benefit from this service is provided to take advantage of low wages in poor and low-income citizens in municipal services. Distribute coupons instead of cash assistance for municipalities, citizens provide for the purposes of using aid (Emrealp, 1993: 32).

2. 8. Pricing Method

This method, in accordance with the requirements of the market prices of goods and services produced by government agencies, so pricing is based on taking into account the costs. In case of application of the method of financing of local public services by those who benefit directly would be concerned (Ulusoy and Vural, 2003: 8).

2. 9 Intergovernmental Cooperation

Municipalities substantial financial, technical equipment and the supply of services that require specialized staff sometimes can not be sufficient on their own. The already high cost of this technical equipment and staff generally do not need to have as an individual. In this context, the municipal administration, this kind of service instead of directly to his execution, in agreement with another municipality or public agency can buy, you can offer can make or jointly (Azaklı, 1999: 35).

2. 10. Voluntary Organizations

Municipalities are benefiting from the contribution of voluntary organizations and persons carrying out their urban services. Municipalities; capable, willing, and thanks to the volunteers experienced some municipal services will work free of charge or can provide less cost. Municipalities, various professional organizations, associations, foundations and other parties with the contribution of volunteers and voluntary organizations, achieved significant savings in the conduct of municipal services (Aktan, 1992: 9).

2. 11. Tax Incentives and Administrative Regulations

With this method, tax for local services, duties and fees deduction made from companies or nonprofit organizations, aims to promote fulfillment in terms of urban services (Emrealp, 1993: 30).

2.12. Self Service Method

This method is the most important in all models and is based on a family basis. In many countries of the world in providing services such as health and education offered by the local government and public order is the most efficient system. The execution of public services more effectively and efficiently, "self-service" method should be utilized and the authorities should endeavor to develop this model (Acartürk, 2001: 58).

2. 13. Service Contract Method

Municipality is a part of the transfer to private companies with contracts to appear in local services. This method is especially cleaning, garbage collection, they are charged for services such as maintenance and meter reading of municipal vehicles. If enabled municipalities to private companies for such services, they can more efficiently control over private companies because lighter loads and can provide better quality service and efficient services through these organizations. However, the company offering the service, act like monopolies possibility should not be ignored by municipalities (Bedir, 1994: 32).

2. 14. Legal - Corporate liberalization Method

This method is general and prices in local public services and an end to wage controls, the elimination of the public monopoly, an end to the advantage of subsidies kind provided to public enterprises, in short, the public sector and private sector in all kinds of barriers to competition legal and administrative arrangements refers to the elimination. The purpose of the legal institutional liberalization process, to increase effectiveness and efficiency in resource allocation in the public service (Ulusoy and Vural, 2003: 10).

3. Contribution of citizens municipal services

The most important asset of these services in the communities where the production and consumption areas are using that service. Their main purpose should be to produce so glad that use the service. In today's world of increased people's needs, increasing the government is to present the main task of serving the people to these needs is a more trying to answer through local government organizations are real (Torlak, 1999: 9).

While there is no competition between the local government organizations, in particular the satisfaction of citizens're benefiting from municipal services it is important for the activities of the municipal administration. Municipality to measure their satisfaction with the services they receive using the service offered is perceived how the services and services offers those who provide information about the actual performance, in terms of seeing the strengths and weaknesses of municipal management is important (Cankuş, 2008: 7).

Ensuring citizen satisfaction associated with the quality of service provided. According to the understanding of modern services, municipalities can be considered successful to the extent that citizens fulfill their requests and demands (Torlak, 1999: 11).

Municipalities can meet the needs of people living in a town can improve citizen satisfaction and a sense of proportion and purpose of the organization will have to fulfill its essential function (Duman and Yüksel, 2008: 43).

Citizens demand from municipalities and expectations vary over time depending on the economic and social reasons. But be very scarce resources it needs and expectations of municipalities are to be effective and efficient. Their experiences in the past users, educational level, personal characteristics, service-related advertising and activities such as public relations, established with environmental

communication is very effective on information obtained satisfaction level of the users (Sevimli, 2006: 18).

Adaman and the work they have done Carkoglu, not satisfied with the public services provided to the population likely to arise from three causes (Adaman and Çarkoğlu, 2000: 20-21)

1. Preferences are not reflected in public policy; Public managers may not reflect the preferences of the people in a desired manner.
2. Yield losses; It should pay attention to public administration services while productivity. Otherwise, the same amount will be less resource offered services, and this will naturally lead to dissatisfaction in public.
3. To enter into relationships with third-party beneficiaries of public administration; When using the resources they gather in public administration hand, certain people they are in self-interest relationships abused the authority given to them in the intended uses of these resources and groups favoring may or service by acting according to the purchasing efficiency principle may prefer companies that in patronage. This course will bring the dissatisfaction of the people.

Determination of the municipalities in terms of user satisfaction and making continuous situational analysis can be updated, citizens must provide a service according to the demands and expectations as to see a customer (Cankuş, 2008: 8).

Municipalities, local they are local government units have been created to fulfill the need for a joint qualification, the fulfillment of this service should be made to the extent provided that they could measure the citizen satisfaction and based on the findings of strategies to develop citizen-centric be able to perform a service concept (Henden, 2005: 48).

3. Materials and methods

3.1. Purpose of the Research

In this research, citizens, aimed to determine the level of contribution to the improvement of services offered by the municipality.

3.2. Method of Study

As data collection methods in survey research techniques were used. The questions in the survey were developed using literature.

3.3. Data Collection

A questionnaire was used as data collection tool. Directed by answering the questionnaire technique is based. Questionnaires were distributed and completed by taking back.

3.4. Population and sample

The universe of age who reside within the service boundaries of a municipality creates citizens who are 18 and older. The survey sample size used in executing the research was targeted by a return to 530 and 491 units. Invalid 469 valid questionnaires were obtained from surveys taken of return.

3.5. Data Analysis Method

469 Data provided by the citizen participation survey were analyzed statistically. The classification and analysis software package SPSS 19.0 for Windows was used. In the analysis, frequencies, proportions, mean, t-test, ANOVA, reliability and validity analyzes were performed. Into evidence statements obtained through a survey transformed and interpreted.4.

Results

Table 2 also shows the age groups of respondents. The distribution of the respondents in terms of age groups are as follows: 20 years and under 7.7%, 34.1% aged 21-30, 31-40 years old, 26.9%, 19.6%, 41-50 years, 51-60 and 9.8% aged 60 years and over were determined as 1.9%. The highest group among the participants of the survey shows that, as seen in the 21-30 age group and 31-40 age group.

One of the respondents to the public services provided by the municipality "streets, alleys, general cleaning of the public areas such as parks" pleased to have been asked about participation. As shown in Table 3, 0.9% of those questioned said that they have no idea about such a service, 20% is dissatisfied with any of these services, that is 17.9% less satisfied, 25.6% medium It heard that the level of satisfaction, is pleased to 28.1% and 7.5% stated they were very satisfied.

Consequence

This study sought to demonstrate how the evaluation of participation of citizens to public services provided by the municipality. These and other studies highlight the municipal holding, it is deducted to improve the quality of urban life. Great responsibility not only to state enterprises to municipalities for public services citizens are dissatisfied with the admittedly falls. Therefore, the central government should be in coordination with the local management of public services being offered. Considering the developments in the world is a localization weight gains in public service delivery is real. As well as private sector organizations, municipalities, non-governmental organizations, associations and so on. organizations also important tasks is reduced.
