

# **MENTAL HEALTH, LEARNING MOTIVATION AND STUDENT ACADEMIC PERFORMANCE IN MEDAN**

## **Introduction**

Teenagers are a very important moment in individual development, as nowadays physical, emotional, cognitive, social and moral developments are very critical. At this stage their identities are being formed and teenagers will make a difference about what education and career they will take in the future. The choices they make at this time will affect their lives in the future (Berk 2011; Unicef 2011). For that reason, it is arguable that teenagers need attention and guidance from parents, teachers and society.

Currently there are about 1.2 billion teenagers around the world. Some of them have sufficient access to education, basic needs and living in safe conditions, but some have survived the uncertain and critical global change situation (Unicef 2011). Reports from mental health bodies of European countries state that one in five children and teenagers are said to have mental health problems (Jané-Llopis & Braddick 2008). Among the events that threaten the development of adolescents are the disastrous events of natural disasters and the disastrous consequences of human-made disaster such as the ever-increasing armed conflict in the Middle East to date (Fasfous, Ramirez & Garcia 2013).

The results of the study conducted by Grayman (2009) on the mental health of Medan community in 13 districts showed that 53% of the sample population were victims of military violence, 5% of women reported that their husbands were missing or killed, 4% lost their children, 51% claiming their property was destroyed or burned, 44% claimed to witness physical torture. The investigation also showed a depression rate of 33% and Post Traumatic Stress Disorder (PTSD) of 19% among Medan communities, the figure was quite high according to Grayman (2009). This problem should be taken into account by educators as well

as mental health practitioners, especially in making proposals and policies on the rules in the education world, (Lana, et al.2008).

The Medan region has experienced a massive catastrophic tsunami. Musa et.al (2014) states that the tsunami disaster occurred in Medan on December 24<sup>th</sup>, 2004 with the 9.2 Richter scale earthquake. The waves of water struck and resulted in the enormous casualties of 129,775 people dead, 38.786 people were lost and 504, 528 homeless. This catastrophe is the culmination of the conflict since 1953, an armed violence conflict that caused a massive loss of life (Reid 2006) including physical, social and economic health losses. Disasters are allegations and heavy dependents in terms of individual ability to adapt. This can lead to the emergence of mental health problems such as post traumatic stress disorder (PTSD). Musa et. al (2014) mentions that people affected by the disastrous impacts such as Medan and West Sumatra have the potential to experience depression and anxiety disorders as well as stress.

It can be concluded that social and community problems and issues in the Medan region are particularly important in education, which need to be understood and further explored. The study aims to supplement previous studies on the effects of a disaster on the mental health of student learning motivation and academic performance. So far, studies on students' mental health and their links with learning motivation have been carried out in many areas where the environment is not turbulent in the disastrous region or the conflicting region. The study which specifically reveals the mental health and learning motivation in the Medan region so far is still very less so it is worthwhile to carry out. Among the questions underlying the study of mental health and learning motivation in the Medan region is whether mental health is associated with learning motivation and academic performance of students involved. Until now, researchers have not found any particular study on mental health with learning motivation especially for students in the disaster-specific areas in Medan Region. This study is expected to serve as the basis for intervention programs and psychological assistance to students in disaster-stricken areas.

## **Hypothesis**

Here are the research hypotheses;

1. Ho: There is no significant difference in terms of mental health, motivation and academic performance of Medan students and Students in Langkat.
2. Ha: There is a significant difference in terms of mental health, motivation and academic performance of Medan students and Students in Langkat.

## **Review of Literature**

### ***Mental Health***

The definition of classic mental health quoted from the White House Conference Preliminary report (Bernard 1970: 13) is:

"Adapting individuals to yourself and the world wide with effective, socially acceptable satisfaction, happiness and behavior and the ability to confront and accept the reality of life at maximum. The highest level of mental health can be described as a matter that allows individuals to create the best of excellence in

terms of their ability and maximum satisfaction for themselves and their social environment with minimal constraints and strains. " (White House Conference Preliminary report, Bernard, 1970: 13).

The World Health Organization, WHO (2004: XVIII) defines mental health as a prosperous condition where individuals are aware of their ability, able to cope with stress in everyday life, be productive and useful, and able to contribute to the community. "

The operational definition of mental health used in this study is a situation where an individual is well prosperous, able to adapt well, be able to work productively, establish social relationships, and be free from emotional and behavioral problems.

### **Academic Motivation**

Motivation can influence individuals to think positively about something. It can also create a sense of attachment and ownership to the organization or institution of work. Motivation can also improve work performance. The motivational traits are said to influence long-term and extensive behavior. In addition, motivation is believed to be a driving force in the completion of certain task motivation, as well as affecting self-regulation. Some studies claim that the trait of motivation affects one's self-confidence to accomplish a specific task (self-efficacy). According to Ningrum & Matondang (2017) Student motivation naturally has to do with students' desire to participate in the learning process. But it also concerns the reasons or goals that underlie their involvement or noninvolvement in academic activities. Motivation is believed to be a supporter in determining goals and commitments towards the intended completion of the goals. In this study academic motivation is an encouragement in a person to follow the academic process and master the lesson material as best as possible.

### **Academic Achievement**

Academic achievement gives long-term impact even in life to someone. This is because education is a good foundation to enable one to have the capabilities and expertise. Good achievement provides better educational opportunities in the next stage. Generally academic achievement also has a significant influence in improving or giving an opportunity for someone to get a better job. At the end of the occasion it will determine the level of income and the individual's finances (Schunk et al. 2010).

### **Relationship between Mental Health, Learning Motivation and Academic Performance**

Anderson (2000) as early as 1993 has stated that processes in the education world are complex and influenced by various factors including motivational and mental health factors. In the 20th century students' motivation was one of the most discussed and studied issues (Thornburg 2005). This is because the motivation factor is directly influenced by student's academic performance. Without motivation either external motivation or internal motivation, it is very difficult for

students to stay focused and feel challenged to succeed (Thornburg 2005; Czikszenmihalyi & Rathunde 1993).

Motivation on school assignments is one of the things that can influence the student's attitudes and academic performance (Thornburg 2005). In addition to the motivation of the learning process is also influenced by the state of mental health, a person who is mentally healthy can use mind intelligence in dealing with problems in their lives.

Unsecured environment, security interference, threats of violence and the like affects the level of focus and the spirit of success in the lesson. The process of learning requires someone to obtain, process and remember. Failure in any of these processes can reduce the effectiveness of learning. The findings of study by Paglicci and colleagues (2002) show that stress symptoms after trauma are closely related to cognitive deficits such as difficulty in remembering and weak concentration. This is supported by Mc Brien (2005) who finds that trauma negatively impacts psychosocial adjustment and student's ability to master language.

Purwanto (2007) states that important elements in learning are thoughts and feelings. A person's emotional or emotional state is influenced by his mental health. Previous studies have found that mental health issues can also affect one's academic attitudes and performance (Stermac & Dunlap 2005). Individual mental health that is exposed to events and disasters is closely related to low learning motivation. This means that when mental health is low then learning motivation is also low. Impacts of disaster often make one feel very helpless. Victims often feel unable to stop the stimulus that hurt them (such as events and violence in conflict). This causes them to be frustrated, hopeless, and not trying to solve the problem (Papalia & Olds, 2001). In other words, in an incontrovertible situation, the individual will lose the impetus to achieve the goals he has anticipated (Purwanto 2007). Stress after trauma is also closely related to cognitive deficits such as distress to remember and low focusing stages and other learning difficulties (Johnsen, Kanagaratnam & Asbjornsen 2008).

The study found that students' mental health influenced their academic attitudes and performance. It should be noted that mental problems have a negative impact on the ability of the students to learn this and also influence the student's emotional development. This impact involves other students or educational institutions where youth learn (Stermac & Dunlap 2005).

Researchers such as Musa et al. (2013), Dybdahl (2006) Reijneveld, Crone & Schuller. et al. (2005) reports on the findings that victims of violence have serious health problems. Mental problems often reported are disturbing thoughts, fears of recurrence of malignancy, anxiety, inability to focus attention, depression, sleep disorders (insomnia), psychosomatic disorders, withdrawal actions, problems of behavior, aggressive attitude, and reactions - dissociation. Studies have found that students at risk from violence or minority families and low-income economies often fail in education and are unable to improve their standard of living. This is because of the existence of discrimination, poverty or residence.

School is an important place and is closely related to mental health as it is the main place where social interactions among adolescents occur and important settings in promoting mental health and well-being of students (Anderson et al., 2009). Therefore education is an important process in the production of human resources as well as efforts to advance civilization, and social development and mobility (Hassan 2002; Hamid 2009). The whole process of teaching and learning is aimed at building human generation in terms of intellectual, skills, emotions and morals and faith in God (Hassan, L., 1997). Therefore education needs to be seen as a process for developing the potential of students. Education is not an art or technique in order to empower the slaves to become a better and responsible adult in the world and the hereafter. (Hasan, L., 1997; Hasanuddin, 2007). In the world of education processes are complicated and complex because influenced by many factors, this is also influenced by mental health problems and learning motivation.

### Research Methodology

This study is a survey study using questionnaire as the number of samples is quite large and interviews are explorative. According to Babbie (2001), survey methods are the best way to collect data from a large population. Through sampling technique, this study also looks at the main variables of the research, namely mental health, learning motivation and the relationship between students in the post Medan disaster.

This study was conducted in two phases. In the first phase, researchers used questionnaires to collect study data regarding sample background, student mental health, learning motivation and academic performance. The collection of research data using this method was chosen because the researcher was able to get general description in the form of descriptive and quantitative (Fraenkel & Wallen 1994). In the second phase of the study, qualitative data was collected through an interview session that provided the opportunity for researchers to make the detection and understanding more in depth. Meriam (1998), has suggested that qualitative research be used as a technique that enables researchers to understand and describe the real situation. Cresswell (1994), states that investigations that combine qualitative and quantitative data collection methods are called mixed methods.

### Population and Sample Studies

Based on census data by the Central Bureau of Statistics and the Medan Regional Planning Agency in 2011, the number of high school students in the Medan Region is as follows.

Therefore, the reviewer thought that the number of samples that should be used in this study amounted to 597 people, that 400 samples came from Medan and 197 people came from Langkat. The number of samples of the study in the view of the investigator is sufficient. This means that the frequency will be near normal if the number of scores (n) in each sample is rather large. This opinion was supported by Gravetter & Wallnau (2003).

## **Instruments**

### ***Measurement of Mental Health Stage***

The measurement of mental health use Self Report Questionnaire (SRQ), (WHO, 2001). This gauge was developed by WHO to screen for psychiatric disorders especially in developing countries (WHO, 2003). The determination of the diagnosis of mental illness can not be executed directly in the investigation unless determined by a psychologist. There are a total of 20 items of question, which are answered equally whether or not yes. SRQ has been widely used in various countries and translated in languages such as Arabic, African, Amhari, Bengali, Filipino, Malaysian, Italian, Kiswahili, Indonesian, Spanish, Portuguese and others. SRQ has been designed as a scale to be filled by the subject. It should be pointed out that the SRQ is only an early screening tool to look at indications of mental health problems, furthermore, to determine the analysis of mental health problems, experts who have authority in providing the diagnosis are clinical psychology or psychiatric doctors (WHO, 2003). SRQ has been used officially in various basic health issues that are undertaken by the Republic of Indonesia's Healthy Part in Medan.

### **Learning Motivation Inventory**

In this study the measuring tool of motivation is based on questionnaires adapted from Ryan (2001) by Harlyna (2004). Adaptation that are run primarily is related to the language and use of IMI in educational settings. This can be done because IMI gives flexibility to modifications for purposes of use, such as the original item reads: "I work hard to complete this activity properly." It can be changed to: "I work hard to solve my every good work", without changing the validity or validity of the measuring tool, basically IMI is a measuring tool intended to understand the subject experience with respect to certain activities. IMI consists of a number of questions contained in various sub-scales, these scales are coherent after several factor analysis tests.

### **Reliability of Instrument of Study**

The instrument reliability is measured by the ability of the tool to obtain a consistent score or result through the reliability coefficient of comparison (Fraenkel & Wallen 1994). There are several other methods used such as Kuder-Richardson test and uniformity test (alpha cronbach). In this study, researchers used the uniformity test (alpha cronbach) to measure consistency in the items involved in mental health and learning motivation instruments. Alpha Cronbach ( $C\alpha$ ) coefficients are the most commonly used statistics for testing the reliability of an investigation instrument. An investigation instrument is said to have sufficient

level of reliability if the Alpha Cronbach coefficient is greater than or equal to 0.70.

### Reliability SRQ

The probability level of SRQ's mental health gauges was tested using the Alpha Cronbach test and reported in Table 3.15.

A measuring instrument is declared to have high reliability if the Alpha Cronbach coefficient is greater than or equal to 70. The findings above show all dimensions in the SRQ measurement tool to record more than the set value.

### Reliability of IMI confidence

To test the level of IMI's realization the assessment also uses the Alpha Cronbach test and reported in Table 3 All the dimensions of the study variables recorded a value of 0.90 and this means that the instrument has a high level of reliability and can be used in the study.

## Results of Research

### *The Relationship between Mental Health and the Learning Motivation of Students in Medan*

Table 4 is a summary of the Chi-Square test of the relationship between mental health and student learning motivation in all areas of Medan.

Based on Chi-Square Test, Pearson Chi-Square value is 1366.242 (a) and significant at level  $p = 0.00$ . This means there is a significant relationship between the level of mental health and the level of learning motivation in Medan.

### **Relationship between Mental Health with Academic Performance**

Table 5 reports a summary of Chi-Square test results of the relationship between mental health and student academic performance

Based on Chi-Square Test, Pearson Chi-Square value is 1299.364 (a) and significant at level  $p = 0.00$ . This means that  $H_0$  is denied that there is a relationship between mental health and the academic performance of the student being studied.

### Conclusions and Suggestions

This study begins with a desire to look at the mental health of students in the Medan region exposed to conflicts and disasters. The experience of researcher living in Medan area saw children and adolescents also becoming victims of the situation. The question is whether they are mentally affected and whether their motivation is affected by the bitter events. The answer can be a guide to helping victims who are involved in conflicts of violence and tsunami disasters. Previous reading shows that mental health components and learning motivation are an important element in academic learning and achievement. This study found that the student sample was affected by events and needed help. In order to produce effective learning, the Medan government and the education department at Medan need to develop policies and programs that support the student's mental health recovery at Medan through accelerating the development of humanitarian and environmental development at Medan. Teachers are encouraged to identify the level of mental health and motivation raised so that teachers can provide guidance, help and supervision. This is important to improve the quality of the teaching and learning process. Teachers must use learning methods that support students to help them survive in this difficult situation. Students will also be encouraged to study as best they can if the teachers understand the situation and are willing to help them. A conducive environment free from stress and fear is the things that can support the success of education.

## XÜLASƏ

### Medan bölgəsində zehni sağlq, öyrənmə motivasiyası və tələbə akademik fəaliyyətinin araşdırılması

Məqalənin məqsədi Medan bölgəsində zehni sağlamlıq səviyyəsini, öyrənmə motivasiyasını və tələbələrə akademik fəaliyyətlərini təyin etməkdir. Nəticə etibarlı ilə, bu vəziyyətlər həm münaqişələrin eyni zamanda təbii fəlakətlərin baş verməsinə səbəb olur. Tədqiqatçı zehni sağlamlıq , öyrənmə motivasiyası və tələbələrə akademik fəaliyyəti arasında əlaqələri araşdırmaq istədi. Eyni zamanda tədqiqatın aparılmasında məqsəd Medan bölgəsində zehni sağlamlıq , öyrənmə motivasiyası üzərində təbii fəlakətlərin təsir gücünü də öyrənməkdir. Bu tədqiqatda istifadə olunan metod sahə işindən ibarətdir, əvvəlcə iki mərhələdə aparıldı. İlkin olaraq, sorğudan istifadə edildi, bu üsulu seçməkdə məqsəd mövzu ilə təsviri və kəmiyyət formasında məlumat almaqdan ibarət idi. İkincisi tədqiqat materiallarının müsahibə sessiyaları keçirilərək toplanılmışdır.

Tədqiqat işində kəmiyyət və keyfiyyət baxımdan müxtəlif metodlardan istifadə edilmişdir ki, bu da qarışıq metod adlanırdı. İstifadə olunan metodlar; Self Report Questionnaire (Özünü hesabat etmə sorğusu), Intrinsic Motivation Inventory (Daxili Motivasiya İnventorları) və müsahibə metodudur.

Tədqiqatda eyni zamanda zehni sağlq ilə öyrənmə motivasiyası arasında anlamlı bir əlaqə olduğunu və öyrənmə motivasiyasının ilə tələbələrə akademik fəaliyyəti arasında da anlamlı bir əlaqənin olduğu ortaya çıxmışdır. Tədqiqat nəticələri onu da göstərdi ki, zehni sağlq ilə akademik fəaliyyət arasında çox əhəmiyyətli bir əlaqə bağı vardır.

## РЕЗЮМЕ

### **Умственное здоровье, мотивация обучения и студенческая академическая деятельность в регионе Медан**

Цель статьи - определить уровень умственного здоровья, мотивацию обучения и академическую деятельность студентов в регионе Медан. Следовательно, эти ситуации приводят к конфликтам, также к стихийным бедствиям. Исследователь стремился изучить взаимосвязь между умственным здоровьем, мотивацией обучения и студенческой академической деятельностью. В то же время целью исследования является изучение воздействия стихийных бедствий на умственное здоровье, мотивацию обучения в регионе Медан. Метод, используемый в этом исследовании, - специфическая работа, первоначально взятая в два этапа. Сначала была использована анкета, целью которой было получение информации в виде описания и количества. Во вторых - сбор исследовательских материалов путем проведения сессий интервью.

В исследовании использовались различные количественные и качественные методы, которые назывались смешанными. Используемые методы - Self Report Questionnaire (Опрос самоотчетов), Intrinsic Motivation Inventory (интраинстинктивный анализ мотивации) и метод собеседования.

Исследование также показало, что существует значительная взаимосвязь между умственным здоровьем и мотивацией, и существует значительная корреляция между мотивацией обучения и академической деятельностью студентов. Результаты исследования показали, что существует очень важная связь между умственным здоровьем и академической активностью.
