

NEPOTISM IN WORKING LIFE

(FAVORITISM)

Introduction

Nepotism is defined as the recruitment and promotion of a person to be recruited based only on blood relatives regardless of their level of education, knowledge, skill, ability and level of success, or irrespective of their suitability for job requirements (Özler, Gümüştekin,2007).

With the technological change in our age, leaving the occupational separation of groups in hiring is felt in every area, and it is becoming compulsory to find suitable personnel for recruitment in business life. The complexity of the work and rapid progress of the change in every stage makes it obligatory for the human resources personnel to have the merit and to hire the right personnel for the right position.

In some developing countries, favoritism is found in the bureaucracy in almost every position, top-down to the basin. In case of the introduction of persons who are educated and not competent in important positions, these persons usually do not accommodate capable and qualified persons in their circle. This constitutes a major obstacle to both economic and social development (Seyyar, 2011).

The concept of nepotism

Nepotism is derived from the word 'nepos' which means 'nephew' in Latin (Kiechel, 1984). This concept, called nepotism, has been used to describe popes,

which tended to make a profit for their families during the Renaissance period (Ford, McLaughlin, 1985).

Nepotism, which is one of the most important problems in our day, is being used for those who abuse their position for the benefit of their immediate family. The types of favoritism such as nepotism and cronyism are highly criticized practices due to their inclusion of behaviors in the working life in contradiction to the rules of the profession (Büte, 2011).

Relative favoritism or 'kin selection' is a natural instinct that exists in people. The biological / ecological approaches in the social sciences state that nepotism is in the category of rational behavior (Özler, Gümüştekin, 2007).

Nepotism is widespread in developed countries as well as the countries where traditional ties and relationships are intensively experienced and market conditions are not improving sufficiently, with more prevalent in family businesses (Özsemerci,2002).

The effects of nepotism on working life

It is obvious that nepotism will cause problems and inefficiency in workplaces where it is concentrated. It is known that many issues such as job dissatisfaction, work stress, mobbing, work health and safety issues are seen among the employees. In order to prevent such problems in business life from being chronic, it becomes more of an issue that preventing unfairness in recruiting private and public personnel, paying attention to the merit in personnel recruitment and jobs to be given to the competent ones.

In workplaces where merit is not taking into consideration, business life will be dragged towards the negative and unhealthy process, and the firm and the country will suffer great harm.

One of the important social consequences of common nepotism practices and policies is the brain drains that may be experienced. For these reasons, a brain drain can be experienced towards developed countries from the countries where these policies are applied. The loss of high-skilled human resources through brain drain leads to a reduction in the competitiveness of organizations (İlhan, Erdem, 2010).

Working under the authority that is uneducated and underprivileged is a disturbing condition for the person who is exposed to the favoritism. The injustice and inequality between the contributions made to the organization and the share received will make the employees feel that they are working in an unfair environment. Under these circumstances, the lack of confidence in the business will negatively affect job satisfaction, organizational commitment and individual performance (Büte,2009).

It is a known fact that the practices of nepotism have reduced the overall efficiency of the organization (Mutlu, 2000). It is also known to have negative effects on absenteeism and job-leaving tendencies (Schmit, 1995).

Nepotism is generally seen in underdeveloped and developing countries. Especially in such countries, nepotism is seen from almost every level in the bureaucracy, from bottom to the top level. It is inevitable that qualified persons will not be accommodated in consequence of the introduction of persons who are not competent to the important and critical positions.

Nepotism is most commonly seen in family companies, and it is observed that this situation often associated with a great deal of adverse impacts and major disadvantages to the success and growth of family companies. Decisions of incompetent people, who obtain high echelons due to blood ties within family businesses, can lead to negative situations as a result of misleading decisions and directions of companies.

Nepotism will turn into a weakness in terms of favored persons; however in terms of employees who work properly, it will lead to the failure of the business and job loss due to the fact that evaluations such as achievement and talent are not considered. If the person to be employed is a relative or acquaintance of the senior management of the business, the objectivity will disappear in the business (Yiisleroglu, 2006).

Favorable attitudes such as nepotism, favoritism and cronyism have increased job stress, which has been shown in studies that lead to job dissatisfaction in employees (Rasli, Tümer,2008).

It is known that the favoritism of a person does not comply with the understanding of law and religious justice, and even disrupt the social order because of injustice.

In addition, unfair distribution of wages and more flexible working hours, special permits, private rooms and facilities that come with favoritism will cause discomfort and problems among employees.

It is specified by researchers that there even are a little positive effects as well as many adverse effects of nepotism. Family members work harder in their own businesses and make more self-sacrifice while many workers do not work selflessly and careful enough for the reason that they are not self-employed. The likelihood of professionally trained members in family businesses to go to other businesses is also diminishing (Abdalla, Maghrabi & All dabbah,1994).

The ability of family companies to make quick decisions without being caught up in the management bureaucracy will make it easier to adapt to environmental conditions.

Merit in working life

The merit system has emerged as a result of the negative effects of the political favoritism system.

It first appeared in the political and administrative literature, with practical abuse of the favoritism system applied by General Jackson in 1828 in the purchase of civil service (Tortop, 1994).

As states' assignments increase and become more complicated, the need for consultation and coordination has increased and they have had to attach importance to the merit system in order to be able to solve and manage this complexity, and to shape the recruitment of qualified personnel with the qualifications and skills required by the job.

There are similarities and differences between the human resource units of public and private sectors besides that, it is observed that the similarities are more appreciable and increasing.

The most important issue in the recruitment process is to hire the best personnel that the company needs. A robust human resources management system is established by recruiting appropriate personnel in accordance with the principles of competency and impartiality.

Merit; is the complete set of rules and practices that enable providing an effective, efficient and rational staff systems. Another definition of merit is a staffing system that entering private or public job positions and promotion depends on the suitability to the work or the measure of success, and also contributes to the efficiency and continuity of the service by the wages and other working conditions applied. Merit in the recruitment process, gain importance not only in the employment process but also in the promotion system. In other words, promotion in one's career should be evaluated with the one's success and competency.

Social moral scientists indicate that favoritism is incompatible with the understanding of justice and honesty of the legal and religious systems, and that it disrupts social order (Seyyar,2011).

Giving the job to the one who is worthy in other words, to be worthy of a job, is the basis of the concept of merit. In Islam, this skill and talent form the basis of a principle of misappropriate which is also social ethics. This is a feature acquired through training and experience.

According to Islamic understanding, a task given or accepted to the person is a consignment. Doing that work properly, in time and honestly is a requirement of fulfilling duty given and acting appropriately.

In the Holy Qur'an, the verse "Stand firm (in the straight Path) as thou art commanded" instructs us to be righteous in our affairs, that is, giving the right of works we do.

In order to make the best of work, we need to be competent for that job, that is, to have the ability to do that job, to have a sufficient level of experience about the business, and to have the desire and determination to do business. That is to say, all of these adjectives coming together is called merit.

Again, in the Holy Qur'an, in the 58th verse of Surah al-Nisa concerning merit commanded as,

“Allah doth command you to render back your trusts to those to whom they are due; and when ye judge between man and man, that ye judge with justice: Verily how excellent is the teaching which he gave you! For Allah is he who hear and see all things.”

After all, without justice and fairness, social peace and tranquility can't be achieved. In environments where justice is not provided, disturbances and irregularity prevail. No one is in a deserved place in societies where favoritism prevails.

It is mentioned about merit in hadith as follows.

With “When a job is entrusted (given) to an unworthy (incompetent) person, wait for the doomsday” hadith, it is stated how big is the importance of giving the job to the competent persons.

Conclusion and recommendations

In general, nepotism is seen to be quite high in less developed, underdeveloped and developing countries. It is known that nepotism is even more prevalent in areas where trust is experienced intensively. We can list the reasons for this as follows.

- Especially in nepotism seen in family companies, relatives being strong in the socio-economic aspect and their willingness and desire to increase social solidarity show themselves strongly in the recruitment process.
- Nepotism appears to be applied in companies where the pressures caused by customs and traditions “Charity begins at home.” and the pressures from immediate surroundings are effective.
- Especially in the eastern societies, the extreme community structure, denominational and religious groups, solid and closed groupings are the areas where the favoritism is seen intensely therefore this situation prevents the development of civil society organizations.
- The nepotism intensity in underdeveloped and developing countries, the lack of understanding of merit and the lack of consciousness on the subject of productivity delay the professionalization.

These are the factors that lead to favoritism, and we can list the precautions to be taken against them in order to reduce the effects of these factors as follows.

- Organizations need to be institutionalized especially in the department of human resources and receive professional support from consulting firms specialized in these businesses.

- It should be paved the way for educated and experienced employees who know the dynamics of the company and business well, have merit and have given years of his to the organization and also precautions should be taken against the

reduction of the motivation of employees who are promoted and assigned (Karacaoğlu, 2012).

- Business managers such as general manager, manager and director who are in the senior executive level, must receive education from business life oriented training programs and have knowledge about elements of business life such as business law, work psychology, human resources.
- In the globalizing world, it should be known that expertise is essential especially in order to be able to apply the business life and policies towards human applied by the developed countries and that it can only be achieved by expert personnel.
- Workshops and seminars should be held to raise awareness of public and private sectors and community about the consequences of nepotism, media tools should be used effectively.
