

A STUDY ON DETERMINING THE EFFECT OF CULTURE ON HEDONIC PURCHASE BEHAVIOR, COMPARISON OF GERMAN & TURKISH WOMEN CONSUMERS

Introduction

What makes a nation is its culture. A nation's culture consists of language, religion, art, worldview, history tradition and custom. To perceive is to recognize the phenomenon with the help of sense organs. According to Young's model; to perceive is to see, hear, touch, smell, taste or feel any event, object or a relationship (Chisnall, 1985:13).

Perception and interpretation of the perceived thing are subjective. The individual perceives the world according to his/her thoughts, beliefs and value judgments. Perceptions occur as the result of sensations. Perceptions are formed according to the individual's previous experiences or knowledge. Therefore, perception is a personality reaction. Its most important sign is a sense of consciousness emerges in the person that the senses belong to a certain object and shape. This definition is done by Prof. Dr. Kartarı (2014); the same validity in the members of different cultures in the way they perceive it, recognizes it, evaluates it according to its reference environments, and defines it with the communication behaviors that its own culture has determined and outlined. The best example of this is the date notion. Date; It is defined as Month / Day / Year in America, Day / Month / Year in Europe and Year / Month / Day in the Far East. These definitions are derived from coding in the country culture. The writing of the history in the language of correspondence in the Far East will be shaped according to the perception of that country. Yet, when generally considered, the dictionary definition and perception of the date notion is the same in every country.

Perceptive definitions derived from cultural differences, this issue also affects people who purchase and use goods and services, it means, consumers. Consumers are influenced by different instincts in their shopping. Consumption is a characteristic that determines the position of people beyond the necessities. This leads to a "consumption culture". The main characteristic of the consumption society is that it does not meet the needs of the people but makes purchases where they can enjoy emotionally pleasure or enjoy during shopping. Briefly, nowadays, consumers do not just go shopping for their needs, but they put forward the emotional or communal dimension of consumption in modern consumption societies.

It can be said that there is a connection between personality and image, product or service. Thus, hedonic consumption and consumer behaviors have emerged in the procurement process, which differ markedly from traditional understanding.

In this research, the effects of the cultural differences of Turkish and German female consumers who exhibit purchasing behavior on pleasure purchase behavior on hedonic shopping behaviors were examined and compared. Testing consumption of hedonic shopping behaviors according to age groups and level of education, especially women's, at the time of purchasing textile products will bring out the effect of cultural difference in this issue with the work to be performed in two different cultures.

In result of this, Germany - Turkey retailers here with international actors who are planning to have initiative to seeing the hedonic value in different cities where the cultural exchange and in particular said that they would gain a significant profit if they can identify key differences in shopping orientations. In this frame, extend to which firms operating in the field are influenced by consumer-based hedonic or cultural aspects will in parallel shape their sales policies. One of the objectives of the study is to develop a theoretical workspace that helps both researchers and retailers alike point to the same need to provide a strong research agenda.

Accordingly, this study consists of four parts outside this introductory section. In the first part following the introductory chapter, concepts related to culture, symbols, intercultural psychology and their effects on consumer behavior were examined. In the second part, the relations between modernism, postmodernism and consumption anthropology are discussed. In the third chapter, hedonism, consumption and purchasing behaviors and shopping styles have been deepened and literature information about hedonic behaviors and cultural perceptions, shopping motivations affecting shopping intentions and purchasing behaviors have been tried to be given to female consumers. In the fourth section, the information obtained in the other sections and the methodological information developed in the aim of the research are included. This section provides detailed information on the method of research, the model and variables of the researcher, the hypothesis of the research, sampling selection, information collection method and tool, and analysis of data and information. In addition, it was planned to

include an application study on shopping motivations affecting purchasing behaviors of Turkish - German women consumers determined from two different cultures. In this application, factor analysis and t test will be used to assess the differences between the two groups. In this part, the evaluation of the surveys applied in the research and the results of the research are presented.

1. Literature survey

1.1. Culture Notion

The culture notion occurs as a concept its context is very wide, and its context is often ambiguous. Generally, culture can be regarded as a sum of symbols developed by societies of every scale in a certain historicity. "Culture; we can say that it is one of the most fundamental determining factors on the needs, desires and behaviors of the individuals constituting the target group. The subculture group has a decisive role on the wishes, needs and preferences of the person, from the choice of food, beverage to the clothing he chooses "(Kocabaş, Elden, Yurdakul, 1999: 124). Culture on the other hand is a specific knowledge, motivation and behavior style. (Earley and Ang, 2003:84).

According to Epstein and Gang (2010: 7), culture is also a concept related to identity and economic issues at the same time. In this context, culture is a comprehensive concept and can come to different meanings. Another interesting point is that the concept and the phenomenon of culture have a dynamic character. At this point, culture is a human process and therefore it has no end.

Raymond Williams (1983) expresses that the culture is a more comprehensive phenomenon and grabs attention that it covers a whole life. Accordingly, culture customs include the system of beliefs, social ethics and even artistic activities. To summarize the concept of such a comprehensive culture; it is possible to attribute the following characteristics: it is learnt, historical and permanent, social, ideological and idealized rule system, has a characteristic for fulfilling the requirements and supplies satisfaction, it changes, integrative and an abstraction (Kocabaş, Elden, Yurdakul, 1999: 117) . In this frame, culture is transferred from generation to generation with forms of formal or informal learning and teaching, and it changes in an absolute way during these transfers. Culture is the current memory of society in any measure. There are very different factors in the formation of this memory. This is a multi-dimensional expression. There is a continuous interaction between these dimensions. These dimensions and culture actually represent a discontinuity between societies. In this context, culture is different from collecting from society. It is because each society has different memory and the mechanism of creating this memory.

Culture is also a concept that can vary among genders (Pfau-Effinger, 2012: 534). From this perspective, culture has an important place in an approach that changes the behavior of men and women, and therefore it also changes consumption habits (Epple et al., 2015: 2).

The culture has been expressed before as an abstraction. Cultural abstraction means that the culture is actually composed of imaginary values and forms. These values and forms can help you to understand the differentiation of the culture's basis. In this context, Fukuda mentions four basic cultural processes and differentiation manner (Fukuda, 1991: 40). These are:

Culture as Compatible Systems: As compatible systems, culture is a form of social behavior. It emerges in harmony with the environment of the person and is differentiated in the way that this harmony requires. The difference therefore arises from the relations of societies with the environment. In this context, different cultures can be formed in different environments. With its simplest form, the difference between societies living in poles and those living in tropical climates is derived from environmental influences.

Culture as Cognitive Systems: According to this thought, understanding and comprehension in culture basically occurs and changes according to the power. This is the place that the memory is, the language is active and shaping the culture. In this context, there is a different culture and memory available in different languages speaking societies.

Culture as Structural Systems: According to this understanding, cultural differences derive from structural differences. The structures here are the creations formed by the human mind during the historical processes.

Culture as Symbolical Systems: Here culture is dealt in the context of symbols created by people. These symbols can occur at very different levels. Religious symbols, intellectual symbols or other popular symbols influence the field of culture and create differences between cultures.

When all these differences are taken into consideration, culture is actually a multi-layered concept (Williams, 1983: 5). In the first layer culture emerges in the context of mental activities. Here, culture is considered as a process sense involving aesthetic and intellectual development. In this context, culture becomes an area produced and directed by the elite group. It belongs to a singular, exclusive and one group. In the second layer, culture is about the life style of a society. It is not only the artistic creations that are mentioned here, but also the daily work of the culture. Accordingly, culture includes much more daily items such as religious rituals, literacy rates, sports, food habits.

On the other hand, culture is the whole of values, symbols, and rituals that are reproduced within our daily activities, meaning that individuals are actively interacting. In this respect, the culture change tendency to resist is high, but it is also very sensitive due to the active interaction of the individuals and their ability of using things independently (Küçükcan, 2011: 29). Williams (1983) states that

culture is the third layer and indicates that it is about producing meaning. For instance, the sequences or advertisements we watch on television also serve to culturally produce meaning.

When all these definitions are taken into consideration, culture can be defined according to who and what context is used, and meaning can change according to the branches of science that deal with the subject (Özgür, 2007: 5). According to the branches of science, culture can be defined in the following forms;

According to Edward T. Hall (1976:433) "culture is communication and communication is culture".

According to Birdwhistell (1972:121) while expressing the cultural structure he focussed on communication and process.

According to Brislin (1994:79) "a culture is specified with common beliefs, experiences and value judgements, connected to each other with these common experiences and can be understood as a group with common historical past".

According to Goodenough (1964:36), "Culture of a society is nothing more than a thing that a person know and believe just for being accepted from members for processing depending on their wish.

1.1.1. Consumption Notion

Consumption can be defined as the total of the activities that occur following the production and exchange process in the simplest form. According to Özdemir (2007: 4), the meaning of consumption can be considered from three different perspectives; the expenditure of income, the purchase of certain goods and services from the market, and the utilization of households.

Consumption can be defined as the process that results in the decision to purchase and it is an individual behavior (Özdemir, 2007:4).

Consumption is obligatory for industrial capitalism. Consumption is the services and goods we use to meet our needs in this context. Now, however, consumption has gone beyond this lean meaning, its semantic and domain has expanded. In other words, an ideology has become a form of relationship and existence. The Althusserian sense has become a process in which one is self-conscious. In this context Baudrillard's definition is quite meaningful. "Consumption is an effective and collective behavior, pressure, morality and an institution. Consumption is precisely a system of social values, a system of social values in which the term is included as group integration and social control function "(Baudrillard, 2004:95).

Consumption, therefore, has gone beyond being an economic concept, transformed into a series of values that describe and characterize existence. At this point it is possible to talk about two different consumption processes that produce and contain these values. According to Baudrillard, these processes are (Baudrillard, 2004:67).

- The meaning and communication process based on the code that the consumption activities enroll and acquire meaning,
- The process of social classification and differentiation, not only as differences in the meaning of objects in a code, but also as statistical values.

Consumption can also be considered as communication process from the other side. Communication is the sum of the activities people do with society and the process by which one expresses itself as a part of society. On the other hand, it refers to discrimination and difference with other groups which do not belong by determining the place of society where the person is part of the differentiation process. The goods can be said to be part of a living information system (Özdemir, 2007: 4). Thus, consumption has become an image of an abstract concept by becoming an image as a commodity. At this point, consumption and interest in the creation of perception and perception are also important areas. The hedonism culture relationship based on the issue of work and the buying behavior can also be related to the change of consumption perception.

1.1.2. Ready-to-wear Consumption

In the definition, garment consumption is a type of consumption that has a symbolic meaning and serves psychological satisfaction that people are involved in purchasing at a high rate. Here, clothes; the social status of the people, the image of the personality characteristics of the car becomes a vehicle. Therefore, the needs that are met through garment consumption will be indicative of social and economic factors affecting people.

Consumers in the fashion industry are defined as quality-focused, socially-influenced, and affordable.

Taking into account the definitions, female consumers are divided into four groups: fashion lawyers, quality seekers, lack of aesthetics and utilitarian. According to this, the categories according to the needs in garment consumption can be created as follows (Kim et al. , 2002):

- 1) Functional needs:** Quality seekers, pragmatists
- 2) Social needs:** Socially impressed people
- 3) Experience based needs:** Fashion advocates

In many studies it has been found a strong relationship between fashion leadership and experiential needs. Underneath the needs based on experience; The quest for change in people lies in diversity, new experiences and assertiveness.

Clothing is a reflection of cultural categories and cultural principles. For example; trousers and skirts do not only reveal gender differences but also reflect differences in the behavior of people in different cultural categories (Arnould et al., 2004).

1.1.3. Hedonism Notion

People are in need of for being able to cover their physical and psychological needs so that they can handle their lives. The term “delight” is one of these requirements that must be met. In fact, this concept of pleasure has been explored and developed by many philosophers and has created a philosophical movement called hedonism. The tradition embodied in Dionysos in the ancient Greek mythology accepts delight as the basic moral principle.

Conceptually, pleasure means; being satisfied from any object with sensory and spiritual happiness.

According to Aristotle, pleasure is an activity required by the natural state of human being. It develops the pleasures that satisfy the people the most and ultimately perfection of life (Özdemir, 2007: 71). In this context, pleasure emerges conceptually as a problem of existence that surrounds and defines life. However, these proposals are quite generic and this concept, which many philosophers are trying to deal with, is quite varied. Among these different approaches, it is possible to regard Aristippos's approach, Epicurus's understanding, Spencer's theory, traditional and modern hedonism.

Hedonism, in traditional context is handled in two parts as philosophical and psychological. In philosophical hedonism, the individual is the ultimate goal and the pleasure is the highest level. Psychological hedonism is tried to be expressed by motivation. Individuals tend to consume what they enjoy (Fromm, 1991: 19-20).

Another distinction is traditional and modern hedonism. The delights taken through the senses are traditional hedonism (Yanıklar, 2006: 102). The degree of hedonism may vary from person to person, from society and from the situation. Instead of patience, the immediate demand for satisfaction in the individual is the front plan (Odabaşı, 2006: 111). Consumers, on the other hand, are defined as hedonists, who are interested in pleasure in principle, individuals who try to achieve their own goals and who do not care about others. There are many variances such as demographic, socio-economic, personality characteristics, values and lifestyle (Yanıklar, 2006: 101).

On the other hand Spencer deals with the concept of pleasure in a dual opposition and psycho-evolutionary framework. According to him, it is an organic phenomenon and a biological function with anti-humor. Traditional pleasure applies pleasure as a form of power. On the other hand, modern hazratists treats the concept of pleasure as a concept that can be produced and consumed. Everything worths consumption and market in modern boring stuff can turn into a pleasure object. Emotions can also be the subject of this pleasure independently of their

content. What is crucial here is which prerequisites must be met before the sensation is used for hedonic purposes (Özdemir, 2007:76).

In this frame, the concept of pleasure has become an important and diagnostic function of today's consumer culture. Shopping is no longer a matter of need, but a matter of pleasure.

1.1.4. Hedonism, Consumption and Shopping

From a wholistic view of the shopping experience, consumer behaviors during shopping are becoming more and more evident. This view of integrality requires retailers to focus on consumer sentiment. Thus, the focus of the retailer is on what the retailer means to the customer than the store itself. This means that the retailer must realize the "form" of perceiving the same shop as different customers. Three important dimensions have been seen that influence customers' "look" in any retail store.

- Shopping environment
- Sociocultural conditions
- Individual roles, motivation resources and behavior

These dimensions not only see the differences between the customers in terms of individual motivation but also try to model the changes caused by the cultural influence elements on the customers.

When we look at the shopping experience from an overall point of view, consumers' behavior during shopping becomes increasingly clear. The experiential aspect of shopping takes the consumption process as a whole from product dependence to post-purchase use phase as a whole and incorporates basic cognitive-rational knowledge that has hedonic direction of shopping (Hirschman and Holbrook, 1982).

The value of hedonic shopping is related to the pleasures and satisfactions that consumers experience during their purchasing experience when shopping at a store (Griffin, Babin and Modianos, 1996)

According to (Woodruffe, Eccles and Elliott, 2002) it changes depending on;

- (1) People's individual shopping tendencies,
- (2) Cultural tendencies,
- (3) Environment depending on economic and rivalry environment that the consumer do his/her shoppings

2. Research

2.1. Purpose of the Research

This research is structured as an intercultural explanatory study. The main purpose of this study is to examine the effect of the culture on hedonic buying behavior by age, education and country.

In this context, the women selected sample sets from Turkey cluster consists of selected women from Germany. The study also examines the differences and similarities between these two sets.

2.2. Content and Constraints of the Research

Intercultural work has some difficulties. These difficulties include topics such as sample selection, sampling, and variables to measure. The most important problem is that it is at the point of determining whether the results to be achieved are due to cultural differences. In order to avoid this problem, it is necessary to choose from groups that are as demographic similar as possible when choosing the sample from different cultures. The greatest challenge in intercultural studies in this context is to be able to achieve this similarity.

Therefore, while preparing the statements on the scale, the following points were noted; the first is the equality of the questions, and the other is the equality of meaning. It is necessary to pay attention to the questions that are important in the equality of the questions to measure the same thing in different cultures (Hui and Triandis, 1985: 141).

In the meaning equality, it requires that the questions have the same meaning in both of the comparative cultures (Douglas and Craig, 1983: 69).

Furthermore, the results of the research are limited to the findings obtained as a result of the answers given in the final scales.

2.3. Structuring of the Research

The survey was created by considering the potential problems mentioned above. Before the questionnaire preparation phase, two mechanisms were used to avoid these problems.

The most important of these is the use of existing surveys. The other is to do preliminary work with people from different circles. In this context, "Cultural Scale" and "Hedonic Purchasing Behavior Scale" were prepared by taking advantage of other scales used in the literature with not being coincided with any scale.

Previous studies on scales have been examined, new scales have been developed and used to obtain datum that will provide us with hypothesized scales that can be used from studies. The surveys were organized in two languages, Turkish and German.

3. Methodology of the research

Quantitative research methodology was used in this study. With this application analysis of datum that makes the observations, literature surveys and questionnaire study required and the two newly emerged scales reached out to qualitative dimensions

3.1. Population and Sampling of the Research

Sampling choice is a very important point in all researches. Especially in intercultural studies, the choice of sampling becomes more crucial. In this context, it is important to note that the selected sample is similar.

In this context, referring to the random sampling method from Turkey 150 female consumers and from Germany 120 women were randomly selected consumers.

The datum was collected by the application of the scale. Researchs' datum acquired from women shoppers, at least with one textile product pocket, in shopping centers in Germany and Turkey.

According to TSI datum, depending on results of Address-Based Population Registration System women population in Turkey are 39.229.862 people by 31 December 2015 (TSI, 2015). According to the same results population rate of women between 18-65 age groups are 24.743.583 people (TSI, 2015).

According to Eurostat datum, determined depending on Address-Based Population Registration System Germany women population are 41.362.080 people by 31 December 2015 (Eurostat, 2015). According to the same results population rate of women between 18- 65 age groups are 25.775.439 people (Eurostat, 2015).

Population of the research consisted of people between 15-65 age groups live in Turkey and Germany. For $\alpha= 0,01$ in a population consisted of 50.519.022 people required sampling number are found enough between 180 - 360 number (Andrew, Pedersen and McEvoy 2011).

In the case of quantitative confirmatory factor analysis, estimation is an important influence in giving accurate results, but there is no consensus on how many sample numbers should be (Waltz, Strickland and Lenz 2010). According to Kline (2005), the sampling's article numbers should be at 10 times and this number should not be less than 180. Andrew, Pedersen and McEvoy (2011) indicate that the number of samples is preferably 20 for each item, but it is sufficient to take 10 participants for each item. In addition to the recommendations given in the literature, the number of samples, the number of items, the complexity of the model . A very complex sample without a normal distribution may less analysis of the sample make it troublesome. In our study, the distribution of samples according to SPSS value results is appropriate for the number of samples, and AMOS compatibility index values are compatible.

3.2. Data Collecting Method and Tool

In the research as a data collectin tool, the survey from, consisted of three partsi was used. In the first stage of data collecting tool there is a personal information form includin country, education and age information of participants.

Expressions in the scale are in quintet type between ; “ I certainly do not agree” and “I certainly agree”.

In the third part of the data collection tool, the "Hedonic Purchasing Behavior Scale" developed by the researcher for the textile / clothing sector is included. When the scale was developed these people's studies were benefited; Bardis (1959), Brown et al. (1992), Gaines et al. (1997), Hui (1985), Triandis (1989); Triandis et al. (1988), Richins and Dawson (1992), Scott and Lundstorm (1990), Richins and Dawson (1992), Webster and Faircloth III (1994) and Webster and Beatty (1997).

3.2.1. Factors and Variances used in the Research

In the Table 3.1, two scales, which were used in the research model, were gathered under factor groups, variances and factors were indicated as symbols. Symbols were defined as “e” and “f”.

3.2.2. Method and Result of the Research

Statistical methods were used in the research. SPSS 15.0 and AMOS 22.0 programs were applied for data analysis. Scale scores are presented as mean, standard deviation and skewness descriptive statistics table. X-square's (X^2) rate towards degree of freedom (X^2 / sd), statistical significance of estimated individual parameter estimates (t value), "remain-based" (SRMR, GFI), "dependent variable" in the model fit validation model in confirmatory factor analysis and structural equation models, (NFI, NNFI, CFI) and "average square root of approximate errors" (RMSEA) are used (Bayram, 2010).

4. Findings of research

4.1. Reliability of Culture Scale

When the results of the reliability analysis were examined, the Cronbach Alpha coefficient of 'Culture Scale' was found as 0.79. For all the articles in the measurement, the item-total correlations were higher than 0.30 (between 0.48 and 0.67), and the t values of comparing the upper and lower 27% parts of all articles were meaningful at the level of 0.01 in the Table 4.1.

4.2. Reliability of Hedonic Purchasing Behavior Scale

When the reliability analysis results were examined, the Cronbach Alpha coefficient of the scale was found to be 0.85 and the alpha coefficients of the sub dimensions were found as 0,81 - 0,82 and 0,77.

For all the articles in the measurement, the t-values of the article-total correlations higher than 0.30 (between 0,35 and 0,60) and the comparison of the upper and lower 27% parts of all articles are meaningful at 0,01 level and seen in the Table 4.2.

When the descriptive statistics of the scales are examined as it is seen in Table 4. 4, the points of "Culture Scale", that is, the family values are at medium-high level with 3.47 points; The "Hedonic Purchasing Behavior Scale" points were 2.90 for the products that were purchased as status symbols; materialism 3,45; it was found that the collectivist reference groups were 2.71 and at the middle level with the result of three factor averages of 3.06.

Among these factor groups, it is seen that "Purchasing Products as Status Symbol" with a lowest value of 2.90. "Family Values" with the highest level of 3.47 and "Materialism" with 3.45.

Culture ($\beta = 0,50$; $t = 5,19$; $p < 0,01$) and age ($\beta = -0,22$; $t = -3,19$; $p < 0,01$) variances have a meaningful effect on the hedonic purchasing behavior. The effect of culture variances is positive, and the effect of age variance is in negative aspect.

In other words, when patriarchal, traditional Turkish family behaviors are at the high level, hedonic purchasing behavior is also increasing. As age increases, hedonic purchasing behavior decreases.

There is no meaningful effect of education ($\beta = -0,05$; $t = -0,70$; $p > 0,05$) and country ($\beta = 0,09$; $t = -1,26$; $p > 0,05$) variances on the hedonic purchasing behavior.

In the rating results of hypotheses while culture and age factors on hedonic rating results accepted that they have an effect on hedonic purchasing behavior, the effect education and country factors on hedonic purchasing behavior was refused.

Result and suggestions

Why societies behave differently in the face of facts and events; The answer to why each society is separated from one another while living in the land, in the house, while talking, while shopping, in short, is the secret in the cultures of the societies. Cultural differences as a factor affecting consumer behavior have been the subject of various researches. Regardless of the research method, culture is a topic that no marketer can keep indifferent. The concept of culture is influential in the whole process from the initial steps of marketing to the final steps, product production, packaging, customer communication, and sales strategies.

In the study Culture's effect towards "Hedonic Purchasing Behavior" examined in terms of country; age and education. The research process was started from modern and postmodern periods and evaluated as daily. As a result of these evaluations; the political process in Modernity is mainly of a class and national quality, whereas in the postmodern the shortage of class differences has decreased; conditions for global cultural transitions have become more favorable. In this context, postmodernity is defined as modernity which is liberated from false consciousness. With these changes, consumption values in society have begun to change. Global consumers have formed society, people have become unsatisfied society. In the process, while people live as unsatisfied and unhappy, they are on the other hand looking for a sense of pleasure in the consumption conviction. Hedonism is a dimension in which contemporary consumer society is not seen in the 1960s and has become widespread since the 1970s.

Hedonism refers to the behavior of the fantasy and desires that are stimulated in the consumer by the emotional dimension and the products, which are far from the need-based physical dimension of consumption. Undoubtedly, enjoyment and desire can be regarded as a natural psychological orientation of man. Basically, it will be appropriate to state that people are heading to objects that are painfully pleasurable, pleasurable. Today, people's consumption trends and motivations are different. The main reason for this is the search for people to be happy. People are now searching for new ways to enjoy fantasies in order to escape problems such as alienation, despair, which they live in the postmodern world or are condemned by a sharper expression. Along with this search, people connect emotionally and delicately with people, products, services, objects, or brands.

In this frame this is a cross-cultural explanatory work of study. With this aim, the culture has influenced hedonic buying behavior; age and education. Examples woman with selected sets from Turkey cluster consists of selected women from Germany. The study also examines the differences and similarities between these two sets. The sample consists of 270 participants.

The hypotheses that have become evident by the researcher's customer relations and the analysis of 20 year observations and impressions in the marketing sector have been tried to be explained with the existing scales and methods in the literature and it has been understood that the scales being used can not be analyzed

and measured. The need to develop new scales in order to provide more reliable data and information for producers and marketers has been seen in the field of hedonist consumer behavior, which can be measured more accurately in recent years. For this reason, "Culture Scale" and "Hedonic Purchasing Behavior Scale" were developed for this research. In this context, family values, materialism, products taken as status symbols and collectivist reference groups were examined. The expressions in the measure are in the likert quintet type in the range of "I absolutely disagree" and "I certainly agree".

According to the results of the study, "Hedonic Purchasing Behavior" has a significant effect on the variables of culture ($t = 5,19$) and age ($t = -3,19$). The effect of culture variable is positive, and the effect of age variable is negative. In other words, when patriarchal, traditional family behavior is high, hedonic buying behavior is also increasing. As age increases, hedonic buying behavior decreases. There are no significant effects on the hedonic purchasing behavior of education ($t = -0.70$) and country ($t = -1,26$) variables.

Besides, the cultural differentiation of consuming sub-dimensions and dimensions has also been examined. These sub-dimensions are under the influence of "Hedonic Purchase Behavior" (averages = 3.06); And they are formed from "Materialism" (3,45), "Products Received as Status Symbol" (2,90), and "Collectivist Reference Groups" (2,71).

According to the findings, these two groups (Turkish and German sets) differ in the dimension of family values, although they are similar in dimensions of materialism, products of status symbol and collectivist reference groups. Participants' being in similar dimension of materialism and the dimensions of the products taken as status symbols reveals a universal hedonic direction with a sense of consumption. Culture is not a factor in this sense. People from different cultures are consuming with similar motivations. This phenomenon is an important finding of this study.

Another issue that this research reveals is that people's basic shopping motivation is to feed and satisfy their materialist feelings. The effects of materialistic dimension on consumption, emotional dimension of consumption are examined. In the "Hedonic Purchase Behavior Scale" factor analysis, it is highly significant in this context to have the highest average with 3.45 average. The basic impulse of the women participating in the research is to satisfy the nurse's feelings while consuming. Besides, the family values are quite high. It is possible to connect this to the participants from Turkey and their more traditional structure.

With all these study results, information users, researchers and textile firms will be able to use the indicators of two developed scales to determine their consumption habits and determine the target group. By this means, it is aimed to determine the consumption patterns of the countries, to determine the target groups and to make use of them in the evaluation and application of international marketing researches. When the effect on the culturally hedonic buying behavior in the study is examined in terms of country, age and education, it will be useful to consider these factors in the following way.

Age-Culture Factor: Businesses should take age and culture into account in order to achieve research results for successful marketing. In this direction, it was seen that in the determination of the customer clusters, the age factor has a positive positive effect on the large to small in the results according to the criteria of "Hedonic Purchasing Behavior". In this context, while young consumers are determined to be the target audience, in the cultural sense, local region studies should be done according to the product. Businesses should arrange their product sales policies according to age groups, taking into consideration the benefits that the consumer will provide. At the same time, the dominant culture factor also shows that businesses should pay attention to cultural sub-dimensions in their works.

Country Factor: Another result of the research; countries have no effect on hedonic buying behavior. It is thought that each country has its own cultures and that the cultures are influential on hedonic buying behaviors. However, when each country is considered to be composed of different ethnic groups, the country factor will be seen as ineffective as in the research results. For this reason, whichever country will be the one that exportation is going to done, businesses should focus on the cultural structure of that region and the city, rather than focusing on the culture of that country. Thus, in the light of this method they should aim to regulate sales marketing policies.

Education Factor: Education is ineffective in hedonic purchasing behaviors according to research results. Businesses should develop their sales policies in line with attitudes and behaviors of consumer groups such as habits, needs, satisfaction, benefit, pleasure without taking education level as an effective criterion. It is stated in the literature that clothing, cosmetics and other personal items attracting attention by the environment carry hedonic benefits (Holbrook and Hirschman, 1982: 134). Especially consumers' self-ego notion should be considered in the textile sector. Educational levels of people are not determinant in hedonic purchasing behavior.

Businesses should try to create an emotional connection between consumers and products, emphasizing that the textile product differs from the advertising and promotion studies in that it is an assertive, energy-saving product that is fit for the characteristics of the people. Thus, it will be able to provide competitive advantage for businesses to develop their advertising and promotional activities for consumers' hedonic expectations in the context of products and services.

There are symbolic meanings of products / brands in hedonic shopping's. Consumers often buy products / brands for these meanings. According to the product range, creating different world senses, drawing an image emphasizing presence in the environments where hot relations are established will increase the level of pleasure of such expectant people. For this reason, the delivery of messages in the direction of product / brand advertisements towards consumers will increase the level of satisfaction they will provide from the products / brands. This will affect product sales positively.

In communities where hedonic consumption behavior is common; it is connected to products that the individual consumes self-expression and social acceptance. This creates materialist individuals, making the individual dependent on others and alienating oneself. Individuals looking for happiness objects ignore very important values such as leisure time activities that are real happiness sources, respect in business life, social and family relationships. The hedonic consumption behaviors that a new person wishes are formed without eliminating the created fake needs and the needs for social effects can never be covered. The inability to meet the needs leads to significant social consequences such as pressure, stress, cannot save anything, bankruptcy and increasing crime rates. In addition, over consumption also harms the natural systems that ensure the continuity of communities. With this aspect; hedonic consumption expresses the negative aspect of consumption behavior.

In this research, it was reached out that the brand carries powerful meanings in symbolic consumption, forming of cultural classifications and enhancing of them. Business should use advertisements as a tool so that the meanings of the brands can be perceived clearly as well as the classifications such as social class, status, age are determined. The product or service should be used by advertisers and print media, which should be the duty of advertisers and commercial communicators, and which is one of the most effective mass media in this process. Briefly, businesses should budget for marketing.

The family is valuable in the lives of individuals, so things learned from the family are more valuable in the life of the person. Behaviors and family values are the most important issues learned in the family. The family concept is similar in cultural sense, similar to that in the family, the truths that are learned in the family and many of the accepted facts are the same. The concept of family is similar to that of the cul-de-sac and it plays different roles in different cultures. In some countries family members learn their own learning and decision processes family does not carry an effective role. In some countries, the family prefers the pre-learned things that have been recommended from the past, and continues to live without bothering itself. Therefore, studies that will be done towards social and family structures are important for those working on marketing.

In the research, thematic, geographical and periodic limitations were studied. Besides, limitations pioneer to new fields of research. These limitations are due to the cultural comparison of the survey. It was a very different perceptual seemingly emerging countries such as Turkey and Germany, which developed in the study samples were chosen deliberately. It can be considered that the sample in question is not very similar to each other. It is not possible to generalize to the whole society (German-Turkish) as the research results are in other researches. There is a need for more comprehensive and diverse research. One of the results of the study, R^2 , expresses 30% of the coefficient of multiple certainty; meaning that only 30% of the effect is attributed to the culturally hedonic purchasing behavior, which is a sign that research is needed in different dimensions. Hence, with different studies hedonic purchasing behavior of the culture should be scrutinized.

This research is inherently a quantitative work and qualitative studies are required to deal with the problem in deeper way. This study is another limitation of coverage of women only as an effective consumer cluster. It is possible to conduct studies involving men in order to increase the generality of the results. This study is intended to be an introduction to this field. It is possible to repeat the operation in different sizes for this. Recapping the study in different sectors, including the income levels of the participants and the family structure, will be appropriate to deepen the topic.

Mədəniyyətin Alman və Türk Qadın müştəriləri ilə müqayisədə hedonik alış-veriş davranışlarında təsirinin müəyyən edilməsi

Bu tədqiqatın məqsədi, iki müxtəlif mədəniyyətlər arasında qadın müştərilərinin mədəni və hedonic davranışların satın alma qərarları üzrində təsirini araşdırmaqdır. Mədəniyyət baxımdan araşdırma apardığında, mədəni təsirlərin və ya hedonic davranışların satın alma qərarlarında, modernizm, postmodernizm və tükətmə antropologiyası təsirləri ilə müqayisədə daha önə çıxmasını aydın görmək olar. Araşdırma metodikası, nümunələrin seçimi, hipotezlər və məlumat toplama bölmələrində daha detallı olaraq, tədqiqat işində öz əksini tapmışdır. Nəticə bölməsində hedonik davranışların və mədəniyyətin alış-veriş davranışları üzərindəki təsiri araşdırılmışdır. Tədqiqatın nəticələrinə əsasən, global iqtisadiyyatda davamlı dəyişən qaydalar, ehtiyaclar və firmaların satış siyasəti üçün yeni xidmət təkliflərinin inkişafı hədəfə alınmışdır. Ancaq beynəlxalq ticarətin, mədəni fərqliliklərinə və müştəri davranışlarına necə təsir etdiyi çox önəmlidir. Qloballaşan iş dünyasında rəqabət faktorunun biridə, həyata keçirilən mədəniyyətlərarası layihələrdir. Mədəniyyətlərarası layihələrin nəticəsi olaraq, fərqli məhsul və xidmətlər fərqli mədəniyyətlərdəki müştəri tələbi üçün qəbul oluna bilən məqamdır. Bu tədqiqat işinin mövzusu qadın müştərilərinin satın alma davranışlarını mədəni və ya hedonic davranışlarıyla əlaqələndirməkdir. Nəticə olaraq, fabrik işləri / marka strategiyaları yarana bilər və ya məhsul/xidmət müxtəlif səviyyələrdə təqdim oluna bilər.

Определение влияния культуры на гедонистическое поведение покупок по сравнению с немецкими и турецкими женскими клиентами

Целью этого исследования является рассмотрение влияния культурного и гедонистического поведения клиентов-женщин при принятии решений о купле-продаже в между двумя разными культурами. При проведении исследования с культурной точки зрения ясно видно, превосходство что культурных воздействий или же гедонистического поведения в решениях о купле-продаже, по сравнению с влиянием модемизного, постмодернистского и антропогенности истощения. Методология исследования, выбор примеров, гипотез и сбор данных более подробно отражены в исследовательской работе. В разделе «Заключение» исследовано влияние гедонистического поведения и культуры на поведение при купле-продаже. Основываясь на результатах исследования, целью является развитие новых услуг, постоянное изменение правил в мировой экономике, потребностей и политики продаж фирм. Но очень важно, как международная торговля влияет на культурные различия и поведение клиентов. В глобализованном деловом мире конкуренция является одним из межкультурных проектов. В результате межкультурных проектов различные продукты и услуги приемлемы для потребительского спроса в разных культурах. Цель этого исследования - связать покупательское поведение женщин-клиентов с культурным или гедоническим поведением. Следовательно, могут возникнуть стратегии работы на заводе или брендинге, или продукт / услуга могут предлагаться на разных уровнях.
