

ROLE OF SUCCESSFUL IMMIGRANT INTEGRATION PRACTICES IN PREVENTION OF TERRORISM: ITALY APPROACH

Introduction

The main starting point in this study is the terror events in Europe and specifically in our country. In Europe; France, Germany, Britain, Spain, Sweden, Belgium, Denmark, Netherlands, Norway, Ukraine, in Turkey, with many countries such as Russia, taking place terrorist attacks, has threatened several times by terrorist organizations how it is in Italy a terrorist attack so far the issue of non-regulation in continental Europe has been frequently asked.

In the face of this question directed to Italian Minister of Interior Marco Minniti, Minniti said; “Unlike many other European countries, the lack of terrorist attacks in Italy in recent years has led the Italian security forces to gain experience and experience in the right relationship with Islam, since the 1970s, with the fight against internal terrorism and mafia.” He said that Italian security forces' capacity to use investigative tools and technologies is among the best in the world.

Italian Prime Minister stressed that the integration of migrants is key, as well as being prepared by the security forces for terrorist attacks. He said that “If we look at what has happened since the Charlie Hebdo attack, the organizers of these attacks were the sons of Europe, the product of insufficient integration. A better integrated society is a safer society and contributes to the fight against international terrorism.” Minniti also recalled

that Italy made agreements with the Muslim community in the country to support integration: “We have signed an agreement with all Muslim communities in Italy for Italian Islam. This agreement envisions four considerations: open mosques, imams list, Italian sermons and clear financing” in the form of integration practices in Italy (<http://www.bbc.com/turkce/haberler-dunya-41176022>).

In this study, the effects of integration policies and practices on prevention of terrorism were examined. The main objective is to contribute to the process of establishing / developing the integration policies for migrants / refugees, which are central to the migration from the Middle East to our country, by referring to the concept of migration. For this purpose, the case of Italy, which is considered to be one of the most successful countries in terms of immigrant integration, has been examined and studied. Turkey had always strong economic, cultural and political relations with Italy. In addition to these bilateral relations, both countries are Mediterranean countries and they are receiving countries or transitory for migrants. Accordingly, the two countries have to produce integration policies in order for the migrants to adapt to the country. Italy's integration policy is being developed based on civil society. The immigration policies in Italy are taken into account the integration approach and therefore Italy is considered an immigrant country in the context of the citizenship issue in the 1990's. Due to similarities with our country, Italy is thought that could be a valuable example of the integration of immigrants in the process of Turkey.

Method

In this study, literature related to integration practices and policies applied to migrants/refugees in Italy has been reviewed and information on the subject has been compiled.

Findings

Although the issue of terrorism is not historically new, it is one of the most controversial problems in terms of violent movements. Terrorism is one of the most important threats facing humanity, regardless of the source, reasons and actors. Terrorism according to the International Organization for Migration: “To intimidate a population in terms of its purpose, nature and context, to intimidate a person who does not play an active role in hostilities in a civilian or armed conflict, it is every kind of action to ensure that the organization does something or not” (Glossary of Migration Terms, 2009). Today, terrorism has become a global problem that threatens daily life. This threatening situation of terrorism forces states to produce urgent solutions.

In the analysis performed after the terrorist attacks in Europe; it is stated that educated and uneducated migrants, who were born and raised in Europe, chose to set aside a suicide bomb when it comes to their own countries, and thus punish the country in which they lived. Terrorist attacks are unfortunately the case of French writers, Kepel (2004), an Islamic radical person, who was mentioned earlier in his book *The War for Muslim Minds: Islam and the West*. It has also supported the statements of the groups trying to gather supporters from those living in Paris, London, Amsterdam and Berlin rather than in the Middle East, and the possibility that they would engage in a number of actions. From this point of view, it is thought that closing the borders will not be a benefit and it should not be forgotten that "internal terrorists" cannot be avoided as stated in Nilüfer Göle's many books.

In the last few years, the integration of migrants has been one of the foremost concepts of national domestic policies throughout European Union and throughout Europe (Vertovec & Wessendorf, 2010). The integration of migrants in the host society is an important task of the receiving countries. It is because the group is deeply affected and reflects social change and crises. This situation leads to anger in people who have not been able to integrate and have not entered work and education life. In an individual sense, anarchist attitudes, which can be called "anarchist essentialism" in a sense, do not belong to any place or whose reference is only self-directed, develops. From one aspect, there is a situation of inability to grip. The only thing that can be grasped is the feeling of "we" with fiction references.

Integration within the scope of literature; means that the immigrant society maintains its relationship with the other parts of the immigration society by preserving the different social characteristics and self (Tezcan, 2008). Integration, which is one of the policies of living together, aims to bring the ethnic groups to a synthesis by influencing each other without dissolving each other completely. Conflicting models are filed and different segments of society provide consensus on common grounds. The cultural differences of the minority group are respected as long as they do not conflict with the fundamental values of the dominant culture. Integration model is based on the the minority-majority relationship, principle of equality and mutual harmony. The belief in cultural and racial superiority is replaced by cultural tolerance and racial equality in this model (Tezcan, 2000). Local people and local governments should try to understand the migrants as they are host. Migrants should accept and adopt the city/country in which they live and should be aware of the fact that they are a member of the place they live. Local governments should improve new projects to ensure that migrants are interested in local issues and have a place in which they live.

The integration of immigrants begins on the day the immigrant reaches a new society. The approach of governments determines the outcomes of

immigrant integration and services. This process will affect the integration of the migrants individually. Migrant integration should therefore take into account both the communities involved and the demands of migrant individuals and societies (Ecre, 2016). However, migrants have their own specific needs, unlike regular societies. In addition, it should be considered that they are more fragile. Therefore, special needs of migrants should be taken into account in integration policies that will be in mainstream policies. Active integration policies in Europe have begun to be realized in a significant way in recent years. These policies aim to increase the opportunity and equality of social, cultural and economic life, access to professional education and social services, socio-cultural integration and civic engagement from different perspectives. Projects that have a positive effect have also come to the forefront and special trainings have been highlighted to increase awareness and to guide people to manage differences. There are efforts to create equality and to support the fight against crime. In order to achieve all these objectives, a special Action Program at the European Union level was achieved with the participation of all member countries.

Generally, at the European Union level, the programs for migrants can be listed as political participation at the local level, citizenship acquisition, family reunification, access to the labor market, shelter and protection of the cultural values of the guest society. The lack of integration policies will lead to the deterioration of values such as equality, democratic representation and social cohesion that the European Union wants to establish in Europe. The European Parliament supports the co-operation of units consisting of voluntary sectors, social organizations and migrants for integration of countries (Tekin, 2009). The issue of including migrants was generally evaluated economically and policies were developed accordingly. However, it was understood that the area where the host society had the most problems was the non-economic issues. Therefore, in addition to economic integration, issues such as culture, language, education and prejudice should be put on the agenda.

In integration policies, policies should be developed to ensure the coexistence of both cultures for integration, noting that the neglect of ethnic culture will initially lead to assimilation and then to a marginalization where people will move away from both cultures, leading to the emergence of a problematic generation.

Europe Union Integration Frame

The integration strategy should cover all areas of society and include social, political and cultural aspects. This strategy should respect the dignity of the migrants and their separate identities and take account of them by establishing policies.

Directive 2003/86 /EC determine the relevant rules on family reunification. In April 2010, the EU Commission published Chapter 3 of the Handbook for Policymakers and Practitioners on Integration and in July 2011 implemented the European Agenda for the integration of third country nationals. In June 2014, the Justice and Home Affairs Council of the EU Member States reaffirmed their commitment to the implementation of the Common Fundamental Principles for the 2004 Integration. In June 2016, in order to assist member states in the integration of some 33 million third-country nationals legally residing on the territory of the Union, the EU Commission submitted an action plan including a framework for action and concrete initiatives and migrants in Europe (Guidebook for local bodies and operators on integration of migrants in Europe, 2015).

Immigrant integration can be seen as the social integration that the United Nations news center defines as a dynamic and structured process in which all members are involved in maintaining and peaceful social relations. Social integration does not mean compulsory assimilation. Social integration; It focuses on the need to move towards a safe, stable and fair society by improving the conditions of social disintegration and social exclusion, and by expanding and strengthening social integration conditions to harmonize, co-operate and coexist in peace (Guidebook for local bodies and operators on integration of migrants in Europe, 2015).

In countries encapsulated by the European Union, national integration programs usually have three key components. These are respectively; language education, beginning courses and professional labor market education (European Commission, 2003). Participation in programs is mandatory in all member countries and is usually prepared by taking into account the special needs of migrants. Experts negotiate with immigrants to decide which component of the program is appropriate for that person. In all member countries, integration programs take 2 or 3 years (European Commission, 2003). Beginning courses gives information about culture, the legal system and the history of the host society. While all of these programs are free, some member states pay a small fee because they believe migrants will contribute to the continuation of these courses. The failure of migrants in the integration program in Denmark and Austria has a negative effect on the residence permit. In Germany and the Netherlands, if an immigrant completes the integration program successfully, it is awarded with a certificate of achievement. Furthermore, this document reduces the 8-year period for naturalization in the Netherlands to 7 years. Southern European countries such as Greece, Spain and Portugal are faced with intense migration in recent years; for this reason, the integration policies of these countries aim at adapting the immigrants to the labor market successfully by adapting them to the job market rather than speaking the language of the guest society or teaching their cultural values. On the other hand, member states have begun to act earlier in the context of integration policies for

better language skills and shared values at first step (Entzinger & Biezeveld, 2003). Member States have different views on successful integration. While in some countries citizenship is considered to be the end of successful integration, in some, self-sufficiency of the immigrant is considered the most real indicator of successful integration.

With the correct steps taken for a fast and successful integration, this process will be an opportunity for the member states, especially where the demographic changes are going on. This also has an economic dimension. Because, in the case of timely and full integration, especially in education and labor market integration, it is explained that the citizens of third country will have a positive financial contribution to the economy.

In addition to forming an indispensable part of the European Union's competitive strategy, immigrants will not have their potential without being integrated into the host society and the economy. The integration of legally resettled immigrants and asylum seekers / refugees applying for resettlement is not only a priority but also an important component of the EU's immigration policy. On the one hand, the integration plan should develop policies to ensure access to rights and opportunities for migrants in the host community while, on the other hand, it should include integration and acceptance of the immigrants with the laws, institutional structure, values and principles of the host society. (Tekin, 2009).

The General Frame in Italy

The immigration policies in Italy take into account the integration approach and therefore Italy is considered an immigrant country in the context of the citizenship issue in the 1990's. That is a fact; the first comprehensive policy emerged in late 1998 and, although evaluated in the context of the emergency, is close to the European approach covering integration regulation. In 2002, this law was reformed by the new center-right government and transformed into a policy characterized as a repressive-legalistic "functionalist position"; new applications such as facilitating entry into the country, facilitating expulsion and limiting the entry of foreigners into the country (Boschele, 2012).

Integration projects since 2007 provide language integration, cultural mediation in different environments and vocational training for migrants and to provide more efficient service to migrants by public institutions are mostly focused on young people and women (Salomoni, 2013).

In the Integration Agreement signed in 2010, the philosophical and theoretical foundations of the Italian immigration policy were discussed for the first time on paper. These philosophical foundations are neither a

pluralism-oriented model nor a model of assimilation. It is a model that argues all cultural and identity characteristics not against the constitution (Salomoni, 2013).

The Italian integration model is neither an assimilating nor a pluralist model. The model is more mixed and fragmented. It can be an invaluable example for Turkey. Local governments play a very important role in this model. Trade unions are also important actors. Since there is no political participation of migrants, trade unions provide a kind of social inclusion. Civil society, charity and political organizations are other actors. While informal solidarity networks are very strong in Italy, formal structures are not very strong (Salomoni, 2013).

The Turco-Napolitano integration law, dated 40/1998 and dated, limits all migration quotas and integration measures to 3 years. In this regard; 1-access to residence permit-admission to citizenship, 2-access to political rights-political participation 3- Evaluation of the Local Councils for power (Consigli territoriali per l'immigrazione), 4-Support for families in social services and access to health services, 5- the need for law change for unaccompanied minors, 6-measures to support the integration of children with immigrant background, 7-guarantee for access to health services for immigrants, 8-changes in the entrance of immigrant children into the education system, 9-acceptance of the qualifications of immigrants, 10-introduction to housing policies under the provisions (Caneva, 2014).

Until the 2000's, integration policies were mostly on economic integration, and social and cultural policies were on the edge. The first change to the cultural understanding of integration emerged as a 'Convention on Values, Citizenship and Integration in 2006 and finally the 2010 Integration Plan (Piano per l'integrazione nella sicurezza) was created. This plan was created in partnership with the Ministries of Interior and Labor and emphasized the need to combine immigrant integration and public safety. For this reason, the plan was adopted by the Italian government for integration activities in conjunction with the Integration Agreement (Patto per l'integrazione) (Caponio and Zincone, 2011).

The plan defines the 5 areas where integration takes place. First area is related to the educational system that helps to understand the cultural values and the Italian values, language courses planned for adults, Italian culture, laws and values. The second area is related to the labor market. Emphasizing the need and importance of the prevention of the informal economy, the importance of supporting the entrepreneurship of immigrants and organizing vocational training courses of the host country are discussed. The third area is related to housing policies. It is emphasized to support immigrants in finding a home and to avoid the formation of ethnic closure

(ghettoisation). The fourth area focuses on social services and access to health services through advertisements, cultural mediators, training for health and social workers, cooperation between country-region-municipalities. The fifth area is about children and second generation immigrants. Special attention is paid to unaccompanied minors by guaranteeing the right to education and a committee for foreign children will be established to develop integration policies. (Caneva, 2014).

In order to obtain a permanent residence permit in Italy, immigrants are required to sign the Integration Agreement and undertake that they will achieve certain integration goals for 2 years. Immigrants have to; 1-Learn Italian (A2 level), 2-Have knowledge of Italian laws and institutions, 3-Learn about Italian citizenship culture, especially health, education and social services, labor market and taxes, 4- respect and implement the law of dispatch children until the age of 16 compulsory education. This agreement is set out on the basis of lending. Signing this provides 16 credits to immigrants, but they are expected to increase this to 30 credits in 2 years. Credits are gained from language courses, Italian history and civic courses, professional and vocational training. If immigrants do not pass the language examination, participate in other courses or face law, they lose credits and if they lose all credits, they are canceled and deported (Caponio and Zincone, 2011).

Today, integration practices in Italy are fully implemented through the European Integration Fund. It is because funds for social policies have been severely cut. Implementation of integration policies is provided entirely at the local level. By years of legal changes and the distribution of duties provided by the Italian Constitution, local authorities in Italy have definite independence in some areas of the state. In particular, the regions plan, organize and coordinate the social movement at the local level and play a vital role in providing social and welfare services (Caneva, 2014).

In Italy, non-state actors are very important and indispensable in migration and integration. Since the beginning of the first wave of immigration since the 1980s, Italian non-state actors have provided support for newcomers and advocated for their rights. These actors are; labor unions, voluntary

associations, Catholic organizations and non-governmental organizations. Today they still struggle for the protection and rights of migrants and take initiative for their integration. ANOLF (National Association beyond Borders), CISL (the most important trade union in the country), ACLI (Christian Union for Italian Workers), Ufficio Pastorale Migranti, Caritas, Doctors without Borders, Opera San Fransesco, Arci, Association for Pro Bono Lawyers non-state actors have a say on immigrant integration. In

2013, 995 associations were established to work on integration (Congia, 2013).

These non-state actors occasionally cooperate with local authorities, but they often substitute for them. Ambrosini (2013) summarizes the responsibilities of non-state actors in four forms. 1- to organize demonstration 2- to promote groups 3- to make legal advocacy 4-execution of services. In contrast, immigrant organizations and non-governmental organizations with an immigrant background are not as effective as Italian non-state actors at least in the public sphere. These associations are created to meet cultural, social and religious needs, to maintain integration and to support the cultural identity of the members (Meli and Enwereuzor, 2003; Caselli and Grandi, 2011). They come together and offer advice in the context of exchange of information, socialization, traditions and rituals. They are mostly shaped by immigrants of the same ethnic or national origin. They are organized on a local scale and only work with their own municipalities (Caselli and Grandi, 2011). Their membership in the public field is only possible through Italian non-state actors (Ambrosini and Caneva, 2012).

As a result, on the one hand, non-state actors are struggling with the political forces against the integration of immigrants (such as the Northern League Party), while compensating for the reluctance and absence of Italian institutions. As an extreme example, Naga provides medical assistance to irregular migrants as an organization in the center of Milan and provides an alternative and complementary service to public services (Ambrosini, 2013). However, other services are provided by non-state actors, thus trying to compensate for the lack of public services.

The Protection System for Asylum Seekers and Refugees, a short name of SPRAR in Italy upon integration, can be considered as one of the best practices. This system is a nationwide acceptance system for asylum seekers and protected persons. A municipality is free to choose to stay connected to the system and open a project of acceptance in its territory. Each municipality has a certain immigrant quota according to the population. The project is generally managed by non-governmental organizations and private associations. These organizations and associations are obliged to provide certain integration services: such as offering Italian lessons, vocational training, vocational orientation, social services. This practice provides personalized programs to assist refugees and to regain their independence, to be part of the Italian community and to integrate them into society (job and housing, access to local services, social life, child education, etc.) (Congia, 2013).

Although Italy is considered an example of immigrant integration, it is thought that some migrant groups are more problematic in political and public discourse than others. African Muslims, people of Chinese origin and Roma are discriminated against. Them; Because of their religion (Muslims), their so-called unlawful participation in the labor market (Chinese) and cultural differences (Roma), they can be perceived differently from time to time (Caneva, 2014).

Result

The formation of a political perspective unity is one of the pillars of the struggle against terrorism. Nevertheless, we should not overlook the social, cultural and economic variables. Therefore, the phenomenon of terrorism necessitates both the politicians in the country and the related parties of the issue to deal with the problem with a radical perspective. Regardless of the measures to be taken, as long as the causes of terrorism persist, problem will continue to exist. Assuming that the political and social inequalities created by globalization will continue in the future, the problem of terrorism seems to be no longer going down.

European countries have developed new strategies with the immigrant population becoming established. It has been seen as the development of policies that include assimilation, adaptation and finally integration including two different cultures. After 1990's, policies on multiculturalism were tried to be produced (Geddes, 2003). The concept of multiculturalism has laid the ground for the establishment of integration policies that will ensure the continuation of multicultural life on the integration of migrants.

Turkey is a gateway between Asia, Europe and Africa continents as a geographic location. It serves as a natural bridge on East and West line. Economy and level of social welfare is an increasingly powerful state of law. These in attractive features increase the migration rate towards our country. Migration, defined as a process of social change that occurs as individuals move from one cultural environment to another temporarily or permanently (Bhugra and Arya, 2005) and when it is considered from this point of view it occurs as a phenomenon of acculturation that means a dual process of cultural and psychological changes as a result of encounters between two or more cultural groups and their members (Berry, 2005).

Turkey is an important aim country/transit country on immigration in recent years while maintaining its national interests and national security to prepare for the country's development to accelerate national economic development it has to create a national immigration policy. It should also enhance all the necessary infrastructures for the implementation of these policies. In the countries that host the most refugees in the world, Turkey is

home to over 3.5 million refugees by the 2018 March. Some of these refugees will continue to live in our country as permanent migrants (Ministry of Interior, Directorate of General Migration Management, 2018). In addition to this, our country has a population of over 900,000 permanent foreign residents as of 2018 (Turkey Statistical Institute, 2018). First time in its history an extensive wave of immigration faced with the Republic of Turkey, rather than short-term measures for the integration of immigrants coming to the country is required to establish long-term and comprehensive policies. It is anticipated that this study will contribute to the development of integration practices and produce information that will provide the basis for the inevitable legislative arrangements in the near future.

Terrorizmin qarşısının alınmasında uğurlu immiqrant inteqrasiya təcrübəsi: İtaliya nümunəsi

Bu məqalədə terrorun qarşısının alınması ilə bağlı inteqrasiya siyasətlərinin və tətbiqlərinin təsirləri araşdırılmışdır. Əsas məqsəd, miqrasiya konsepsiyasına istinad edərək, Orta Şərqdən ölkəmizə köç edən miqrantlar / qaçqınlar üçün inteqrasiya siyasətinin qurulması və bu siyasətin inkişaf etdirilməsinə kömək etməkdir. Bu baxımdan immiqrant inteqrasiyası baxımından ən uğurlu ölkələrdən biri sayılan İtaliya ölkəsinin siyasəti araşdırılmış və öyrənilmişdir. İtaliyada immiqrantlara / qaçqınlara tətbiq edilən inteqrasiya təcrübəsi və siyasəti araşdırılaraq nəzərdən keçirilmiş və mövzu ilə bağlı məlumatlar tərtib edilmişdir. İtaliyanın inteqrasiya siyasəti vətəndaş cəmiyyəti əsasında inkişaf etdirilir. İtaliyada miqrasiya siyasəti inteqrasiya yanaşmasına uyğun olaraq , 1990-cı illərdə vətəndaşlıq kontekstinə görə İtaliya immiqrant bir ölkə hesab olunur.İtaliya, Türkiyədəki immiqrantların inteqrasiyasına dəyərli bir nümunəsi ola bilər.İtaliyanın inteqrasiya modeli nə assimilyasiya, nə plüralist modeldir.

Yerli hökumət, həmkarlar ittifaqı təşkilatları, vətəndaş cəmiyyətləri bu modelin həyata keçməsində çox vacib rol oynayır. İtaliyada formal strukturlar , qeyri-formal həmrəylik şəbəkələrinə nisbətən çox güclü deyildir.

РЕЗЮМЕ

Опыт успешной интеграции иммигрантов в предотвращение терроризма: Пример Италии
