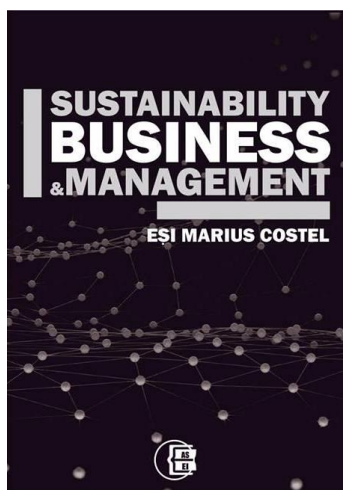


BOOK REVIEW:

On the Sustainability, business & management, written by Mr. Marius-Costel Eşi, Lecturer PhD to „Stefan cel Mare” University of Suceava (Romania), published at ASEI Publishing House, we can specify that it addresses the specialists in the field and beyond. Thus, from the beginning of the book, the reader is warned that through such an exhaustive and epistemological approach, the ideas analyzed and presented come to confirm the legitimacy of some theories regarding the areas of sustainability, business & management. Thus, a series of issues related to such a triad are discussed and the examples provided confirm and justify their pragmatism in relation to the new economic, social and educational paradigms as they are found in the present-day society. Moreover, this book also brings into discussion a series of courageous, assumed, coherent and clearly argued theories, also meant to support the idea of sustainable economics and entrepreneurship. In this way, issues of divergent thinking are brought into discussion, corroborated with elements of a strategy built upon the principles of sustainability and environment.

Sustainability, business & management: a pragmatic book for anyone who hates being wasteful, who does not want to start a business, and who does not want to have any kind of educational, social and economic vision

The book has as a starting point the *differentiated sustainability model* according to which *any resource effort involved in a business must be at least directly proportional to the quantity and quality of the underlying investments plus at least three capital units with sustainability circulating power*. Taking into account such a *differentiated sustainability model*, explained and applied (in an intuitive manner) at the level of discipline field theory (the *Theory of disciplinary fields* is a reference book in understanding such an approach), this book does reference to the idea of resources and its conceptual and theoretical derivatives that can find their usefulness at the level of humanity in general.

Thus, the contents of this book contain a series of theoretical and practical re-evaluations regarding the organizational business vision and mission in relation to the idea of an organizational axiological nucleus. New models of organizational behavior aimed at revealing new needs in a new system of values are considered. Moreover, the highlighting of an axiological support built upon a new socio-economic paradigm is centered on everything that society represents and offers as a whole.

Such an example already mentioned is that which allows conclusions such as in the social-economic environment it can no longer be spoken in exclusive terms of “useful” or “pragmatic”, but rather of “sustainable” or “unsustainable”. Therefore, the axiological system also has a mutation at humanity level, thus defining an entire social and economic system.

Given the shift of mentality, approach and thinking at the general level of humanity, it is obvious that the axiological system at the organizational level experiences some mutations. But such mutations in human thinking only “prepare” society in its approach of becoming as sustainable as possible. In this sense, we can talk about a sustainable education, a sustainable economy, a sustainable society, a sustainable business, sustainable management, sustainable thinking, and so on. Therefore, we find that the term “(sustainable) mutation” becomes fundamental in the process of developing a sustainable society.

A special place in this paper is granted to the concept of bio-economy in relation to the concept of environment. In other words, a series of aspects related to the economy of the society and the effects it has upon the environment are analyzed. Some of the shortcomings and limitations of today's society in terms of policies to stop / mitigate harmful effects on the environment / humans are highlighted.

Thus, on the one hand, the surrounding realities reflect different paradigms of thought. Such a situation requires a diachronic analysis, but also a synchronic analysis of what the entrepreneurial-philosophical relation (in the sense of pragmatism) represents in the present day society. On the other hand, rationality and affectivity can provide a lot of landmark for assuming a sustainable thinking, considering the theoretical and practical dimensions of the utilitarian consumption ideas and of the opportunity cost ideas. The rational and irrational can also become indicators aimed at providing an exhaustive picture of what sustainability generally means.

In conclusion, the book *Sustainability, business & management* contains two main aspects that are worth retaining:

- (1) an aspect that highlights the need for sustainable thinking at the level of the human society in relation to its needs and resources,
- (2) an aspect that reveals the necessity of assuming new paradigms at the level of the dimension of sustainability given that this has a dynamic and complex character

by the decision-makers in organizations as outlined by the decision-makers' priorities and the justifications thereof.
