

ANALYSIS OF INSTITUTIONAL CAPACITY ON SUSTAINABLE DEVELOPMENT PLANNING OF POPULATION PROGRAM, FAMILY PLANNING AND FAMILY DEVELOPMENT (KKBPK) IN ACHIEVING TARGET SDGS IN MEDAN CITY

I. Introduction

One strategic program in improving the quality of life of Indonesian people is the Population Program, Family Planning and Family Development (KKBPK) which aims to build small and quality families as an important effort in achieving sustainable development. This development is directed as an effort to increase and develop the quality of the population through family planning, with the realization of a small family that is expected to be the basis for the growth of a quality family that provides opportunities for the formation of more reliable, resilient and independent Indonesian human resources.

Management of the KKBPK program at the national level is carried out through the National Population and Family Planning Board (BKKBN). The issuance of Law 23 of 2014 concerning regional government, in which it states that the management of population and family planning programs is carried out by the service both at the provincial and district / city levels as a mandatory affair even though it is not basic service. As a program manager at the national level, one of the strategic efforts carried out by BKKBN was through sharpening the priority of program development through regional segmentation which was carried out since the beginning of the program.

For 2017, in the North Sumatra Province, regional segmentation was arranged in the management of the KKBPK program to provide feedback to managers, in the form of describing the strengths and weaknesses of program implementation at all regional levels. Based on the analysis of regional segmentation in the BKKBN field control data there are several regions included in the priority area segmentation. Among them are the City of Medan which is one of the strategic areas in the main buffer program in North Sumatra. Based on the results of regional segmentation in terms of the impact of the program in the community, the management of the KKBPK program in Medan City is still included in segment III, which means that it still has no significant impact on purpose.

II. Review of Literatures

2.1 Institutional Capacity

In a dynamic sense, capacity is the ability and energy to make a change. Capacity can be tangible; (1) Ownership of facilities, (2) attention to people's dignity and (3) the ability to dissolve and think about themselves in shaping the future (Briyant and White 1987). Dynamic review of the capacity of institutions and individuals in the process of changing people's lives as well as the prerequisites for the capacity needed to be able to display the tasks and functions as well as possible.

According to Hamilton in IFAD (2013) regarding the definition of institutions. "Institutions that can be understood as settled, are widely prevalent and are standardized in terms of defining social practices and - more formally - governing constitutional and operational rules of different kinds of organizations." In this case, institutions are considered as a forum that regulates standards of behavior with certain standards that formally have rules as operational rules in regulating relationships between organizations.

According to Milen (2004: 12) capacity as the ability of individuals, organizations or systems to carry out functions properly in an effective, efficient and continuous manner. Furthermore the term should explain that functions must be specific and defined in each case which must be adjusted to the basis of several criteria. In carrying out the functions, there are certainly many things that will be faced, as also stated by Milen (2004: 17) that capacity building requires a long time and requires long-term commitment and all parties involved.

2.2 Development Planning

The concept of development is usually inherent in the context of the study of change, development here is defined as a form of change that is planned; every person or group of people would expect changes that have a better and even better form than before; to realize this expectation certainly must require a plan. Planning development is more felt as a more rational and orderly effort for the development of communities that have not or are just developing. (Subandi: 2011: 9-11)

Development was initially used in the sense of economic growth. A community is considered successful in carrying out development, if the economic growth of the community is quite high. Thus, what is measured is community productivity or state productivity each year (Rochajat et al: 2011: 3). As for the trend of development concepts developed in Indonesia (Wrihatnolo and Dwijiwinoto (2007) suggest the existence of stages (1) growth strategies, (2) growth and distribution, (3) appropriate technology, (4) basic needs, (5) development sustainable, (6) empowerment.

2.3. Population Program, Family Planning and Family Development (KKBPK)

According to Philip M. Hauser and Duddley Duncan (in Mantra, 2000), demography is the study of the number, distribution, territoriality, composition of the population and changes and causes that usually arise due to birth, death, migration, and social mobility. Demography is divided into pure demographics and population science. Pure demographics only describe or analyze demographic variables, while population science learns about the relationships between demographic variables and other system variables, one of which is economic variables. Population is an important element in efforts to increase production and develop economic activities. The population plays an important role because it provides labor, experts, company leaders and business people who are needed to create economic activities. Besides that, population growth has resulted in increasing and increasingly complex needs (Sadono Sukirno, 1985).

Population growth in an area is influenced by fertility, mortality and migration. If the fertility rate is greater than the mortality rate, then population growth becomes positive. Likewise with migration, if the value of in-migration is greater than the value of out-migration, then population growth becomes positive. Population analysis aims to explain basic information about population distribution, characteristics, and changes. As well as explain the causes of changes in these basic factors and analyze all the consequences that might occur in the future as a result of these changes (R. Thomlinson, 1965).

Law Number 52 of 2009 concerning the Development of Population and Family Development states that Family Planning is an effort to regulate the birth of children, the ideal distance and age for childbirth, regulate pregnancy through promotion, protection and assistance in accordance with reproductive rights to create a quality family. A quality family is a family formed based on a legitimate marriage and characterized by being prosperous, healthy, advanced, and independent, having an ideal, forward-looking, and responsible, harmonious and fearful child to God Almighty.

Family Planning according to WHO (in Hartanto, 2003: 26-27) is an action that helps individuals or married couples to: (a) Obtain certain objectives, (b). Avoid unwanted births, (c). Obtain the desired birth, (d). Set the interval between pregnancies, (e). Control the time at birth in relation to the age of the husband and wife, (f). Determine the number of children in the family.

The family according to a number of experts is the smallest socio-economic unit in society which is the basic foundation of all institutions, is a primary group consisting of two or more people who have a network of interpersonal interactions, blood relations, marital relations, and adoption

According to Mattessich and Hill (Zeitlin 1995), the family is a group that deals with kinship, residence, or emotional relationships that are very close which shows four things (ie intimate interdependence, preserves selected boundaries, is able to adapt to change and maintain identity). All the time, and do family tasks).

The purpose of forming a family is to create prosperity for family members. A prosperous family is defined as a family formed based on a legitimate marriage, capable of fulfilling physical and mental needs that are proper, devoted to the Almighty God and has harmonious, harmonious and balanced relationships between family members, and between families and their communities and environment (Landis 1989; BKKBN 1992).

2.4. Sustainable Development Goals (SDGs)

One of the main results of the Rio + 20 Conference, held in Rio de Janeiro in June 2012, was the agreement of member countries to begin the process of developing a set of sustainable development goals (SDGs). The results of the Rio + 20 conference mandated 30 members of the Open Working Group (OWG) from the General Assembly of the United Nations (PBB) tasked with preparing SDGs proposals. OWG itself was established on January 22, 2013. In its journey OWG member countries delivered a series of proposals related to the SDGs. At the thirteenth and final meeting in New York on July 19, 2014, the OWG proposed 17 goals covering sustainable development issues, including ending poverty and hunger, improving health and education, making cities more sustainable, combating climate change, and protecting Forest.

III. Study Methods

The method of this study is a descriptive study method with a qualitative approach. Descriptive methods direct attention to problems or phenomena that exist in the field when the study is carried out, then describe the facts of the problem under study with accurate interpretations. In this case the author will describe the condition of regional development planning based on population conditions as a reference to SDGs and indicators relating to population as a guideline.

This study was carried out at the relevant agencies involved in development planning in the city of Medan, in this case the Office of Population and Family Planning Control and Regional Development Agency (Bappeda) in Medan. This location was chosen because the city of Medan is included in the Region II segmentation which is one of the regions with high population dynamics.

IV. Discussion

Program planning in the musrenbang starts at the village level to carry out development planning which formally seeks to bring together the aspirations of the community from below with the proposed development program from government agencies. A dialogue forum built between the government and stakeholders at the village level covers issues / issues, policies, regulations, or development programs. In musrenbang, the government in the village and the community develops and conducts deliberations to discuss the development program in the village. In the musrenbang, there is an agreement on the preparation of programs and development activities in the village, handled independently through regional assistance posts, as part of the Village SKPD Renja or submitted to be handled by the relevant SKPD.

An understanding of the KKBPk program to stakeholders who will later discuss discussions about the plan in musrenbang regarding the program becomes an important point. Before the musrenbang at the village level, residents were consulted at the environmental level, several community leaders from around the neighborhood were invited to consult with residents, and it was agreed upon what plans for the plan would come to be desired. Related to the involvement of the KB Field Officer.

"If there is a community consultation there we will not be invited anymore, in 2016 we are still invited. Later related to the family planning program, we cannot monitor it because we are not involved in community consultation. "

Based on the interview quote above, during the past two years, family planning field officers were not involved in program planning meetings in the village. In the village musrenbang all the problems raised by the head of the environment are then selected at the Village level. Then they produce a list of proposed priority scales. This proposal is related to the process of knowing, exploring, and gathering information that is local in musrenbang planning by seeing a planning process similar to the stage of data collection or information.

"This year there is no involvement in musrenbang, even though we, for example, participated in the previous years, there were many proposals from the PLKB, but none of them had ever entered the program. People are more concerned with building community infrastructure such as roads or ditches. "

Based on the review of Bappenas and the Minister of Home Affairs for the City of Medan in 2018 the City of Medan will revise the RPJMD, for this program proposals in regional planning must be in accordance with Permendagri number 86 of 2017 can be included in regional planning documents. Proposals for revisions have been submitted and a new Population Control and Family Planning Agency strategic plan was developed after the formation of new nomenclature at the end of 2017.

"The financial people are the same as the Pemko Regional Government, there are activities that should have been updated, and we re-conceptualize it. There we add a program of population control and mobilization. But regarding financial management, we are participating in the Minister of Home Affairs Regulation number 38 of 2018. "

In addition to regional budget funds, the KKBPk program is accommodated in a special allocation fund (DAK). DAK funds cover physical and non-physical development with technical guidelines set by the BKKBN. For Medan City,

related to DAK funds there is a mismatch in regional planning. The DAK funds provided reduce the APBD portion in the Medan PP and KB services.

"Our budget is reduced again from the regional budget because of the DAK funds, so don't want it, so our APBD will become a little bit. If all we know is that the budget should not be attached, because indeed he has been put into the budget, but if it is a balance fund, the DAK funds are not APBD funds. Our budget is reduced by 5 billion from the previous year ".

This budget reduction affects the sharpening of the program to the field. When viewed from the official planning document, both the strategic plan and the plan are in accordance with the permendagri guideline 86. The drafting of the strategic plan is carried out by the agency and is accompanied by experts from the population of North Sumatra. But when coordinating with Bappeda, there was a mismatch in planning. For 2018, the city of Medan also has budget efficiency that reduces the budget ceiling from previously set. The budget allocation for activities for 2018 through APBD and APBN funds based on strategic objectives and performance indicators is described in the activity program as shown in the table below:

For 2018, improvements to the RPJMD were carried out and 5 indicators were proposed that would be included in the RPJMD documents by the agency to Bappeda.

"Even though we have sent it and it has been entered into the system and it reads that we are working on a new strategic plan in accordance with Minister of Home Affairs 86, we have done it twice, entered the system, budgeting RKPD is okay, but in terms of work planning, cool adjustments not matching, including in RPJMD "

Law Number 22 Year 1999 concerning Regional Government as amended by Law Number 32 Year 2004 has changed the authority of the regional government. The regional government is given the freedom to organize a government that covers all fields of government, except those fields which are based on the Law have been designated as central authority. Based on this, some regency and city governments have varied interpretations which have resulted in the implementation system being ineffective. This can be seen from the nomenclature of program managers in different districts / cities. Based on article 12 paragraph (2) letter h and appendix letter (N) of Law 23 of 2014 concerning Regional Government, it is increasingly assertive that population control and family planning are mandatory Government affairs that are not related to basic services which are the affairs of the Central and Regional Governments Provinces and Districts and Cities.

"After this autonomy, we are directly responsible for achieving performance targets to the mayor. It differs from before under direct BKKBN. In setting targets, we also refer to the targets in the RPJMD document ".

Approaches to managing family planning that have been carried out through the BKKBN to carry out and implement their vision and mission have encountered many obstacles to implement. Changes in the authority and structure of family planning management organizations in the regions and hierarchical working relationships between family planning managers at the district level and BKKBN. These changes will further affect the atmosphere and corporate culture of the KKBPK program in the regions that have been implemented so far. Through Law Number 32 of 2004 and Presidential Decree No. 103 of 2001 concerning Position, Task, Function, Authority and Organizational Structure and Work Procedure of Non-Departmental, Regency / City Government Institutions have independence in handling family planning issues, including budget and personnel matters.

In carrying out the main tasks and functions, the Population and Family Planning Control Office of Medan City is supported by 184 staff with the following composition:

In carrying out planning, management of development planning is carried out under the coordination of the secretariat. Planning programs and secretarial activities guided by general city plans, strategic plans and official work plans for the implementation of planning synergy. Implementation and organization of material preparation for standard operating procedures, service standards, job competency standards, job analysis, workload analysis, job evaluation performance reports and other standards of secretarial scope for optimal implementation of activities and tasks.

"There are some people who have been trained in the program to move to another service, now it is filled with new ones from other agencies. So to program with new people, you must start learning again. "

Law No. 17 of 2007 concerning the 2005-2025 National Long-Term Development Plan stipulates that the national development vision is to create an Independent, Advanced, Fair and Prosperous Indonesia. Independence in realizing equal and equal life with other nations by relying on their own abilities and strengths. Advancing with a high level of prosperity accompanied by a system and solid political and legal institutions. Justice without any limitation / discrimination in any form, either between individuals, gender, or region. Prosperity with the needs of the life of the Indonesian people has been fulfilled so that it can give meaning and significance to other nations.

The national development vision for the 2015-2019 RPJMN year is: The realization of a Sovereign, Independent Indonesia and a Basic Personality of Mutual Cooperation.

Based on the Medan City Mid-Term Development Plan (RPJMD) for 2016 - 2021, the 2016 - 2021 urban development vision is set out as follows: "Becoming a Multicultural Future City, Competitive, Humanistic, Prosperous and Religious". Based on the description and expectations of the Medan City Vision, it was determined that the city development mission for 2016-2021 which became the foundation of the KKBPK program was at point 5 (five), namely Encouraging increased employment opportunities and community income through increasing equitable and equitable education and health. This mission was then elaborated with the aim of realizing Medan City as a regional health service center with the goal of increasing access and health services with a strategy to improve access and quality of family planning services.

Determination of this goal is determined by an analysis of the internal and external environment to identify the factors that become strengths and weaknesses that become the resources of the Medan City Population and Family Planning Control Office to deal with opportunities and threats.

In the 2015-2019 RPJMN, the Bapennas will focus on the SDGs target which will provide important colors in the Development Agenda including: (i) human development such as poverty, malnutrition, health development, education and gender equality; (ii) fulfilling people's access to water and sanitation remains an important issue, and access to energy is a new focus added; (iii) for sustainable economic development is a new issue that will be focused on sustained and inclusive economic growth, as well as sustainable industrialization and

sustainable housing and city development which as a whole are accompanied by the application of sustainable production and consumption patterns; (iv) environmental development reflected in the focus of mitigation on climate change, conservation of natural resources and protection of ecosystems and biodiversity; and finally is the means of implementation.

The government through the BKKBN and the Ministry of Home Affairs at the central level and the Population and Family Planning Control Offices in the Province / District / City through the Government's development direction guidelines as stated in Book I of the 2015 - 2019 RPJMN are committed to supporting the development vision and mission to create a balanced population through decreasing population growth rate (LPP) and creating a quality family. In achieving the SDGs target, Population, Family Planning and Family Development Program through achieving the third (three) goals in ensuring a healthy life and promoting prosperity for all residents of all ages and achieving the fifth (five) goals of achieving gender equality and empowering women and daughter.

The Grand Development Design of Medan City was then compiled to be integrated in demographic variables with development variables, harmonization of population dynamics with social and culture in the integration of population issues into development. In the Strategic Plan of the Population Control and Family Planning Office of Medan City, the achievement of the SDGs target until 2021 has been determined as follows:

In the Medan City planning process, the grand document of population design is still not optimally utilized. The lack of coordination and socialization of the results of the grand design is a major problem. As a step to anticipate future events, various main problems are faced in the implementation of the Population and Family Control Service.

Document related to the achievement of the program, indicators of the achievement of the SDGs target have been outlined in the Grand Population Design which is contained in the population control office strategic planning and Medan city KB, but there are still many things that need to be analyzed for future program improvement when analyzing the results of 2017 and 2018.

"In particular, in the planning meetings, starting from the coordination of Bappeda to the coordination meeting to the field line, we never directly discussed the SDGs issue. But we have explicitly arranged in the grand design of population development and set out in the annual target."

Because the indicators that go into the planning document are not comprehensive according to Permendagri 86 of 2017, then there is an influence in the budgeting of the population control office and the Medan City KB. Budget allocations are also smaller because the main focus is on increasing family planning

participation. Regarding APBN funds in physical and non-physical DAK, the budget reduction is quite large in 2018 for the PP and KB services in Medan City. From the support of non-physical funds from the DAK Family Planning Program, the funds absorbed were only 32.23 percent. This amount is supported by family planning counselors, family planning village activities, and family resilience group activities. This fund is related to mobilization in the field, with low uptake in 2018, it can be seen that the lack of optimal program movement in the field. The physical DAK of Medan City in 2018 is not realized. The low level of APBD support related to musrenbang is not optimal in the KKBPK program support starting from the environment to the city level, this has caused very little budget support from the APBD for the KKBPK program. Regarding the alkon managed and distributed by BKKBN, the delay and distribution of alkon causes increased unmet family planning needs and decreased use of long-term contraceptive contraception based on routine statistical data.

Looking at performance achievement data based on routine statistical reports, for Medan city the achievement of KB participants for all contraceptive methods was achieved at 67 percent or 2,017,010 pairs. While for long-term contraceptive use, the number achieved is lower with 30 percent or 62,617 couples. Based on these data, data on the continuity of contraceptive use were obtained at 42.15%. This figure is far above the national tolerance rate of 25 percent. Unserved family planning needs also increased by 19.4 percent or 59,733 pairs. Medan City is the main buffer zone for North Sumatra Province, so that based on this data evaluation and revitalization are needed regarding the planning and management of the KKBPK program. To foster family planning participants through group activities, the coverage of Medan city is still far below 50%. For families who have toddlers 44%, families that have teenagers 37 percent and families that have toddlers 43 percent. While the Prosperous Family Income (UPPKS) business group has a much lower achievement of 12 percent.

Through improvements in planning as outlined in the Medan City RPJMD, the Medan Population and Family Planning Control Office has the potential to contribute more to health development through improving family planning services and reproductive health. The development can be carried out through the formulation of various activities that are directly related to 5 (five) priority activities: family planning services, advocacy and KIE KKBPK, youth development, family development, and institutions, as well as data and information.

V. Conclusion

The Office of Population and Family Planning Control in Medan city is structurally in accordance with the division of structure and workload. In the planning implementation mechanism, the Population and Family Planning Control Office is still experiencing internal and external obstacles in the preparation of strategic programs that have caused a decline in the quality of program implementation in the community. Strengthening cooperation with business partners is important in improving the quality and efficiency of the program to achieve the performance targets that have been previously set. In the planning document, the KKBPK program falls under the aspect of health services with one program achievement indicator. This document is not in accordance with the KKBPK permendagri program performance indicators Number 86 of 2017 with 32 indicators. The Population Control Office and Family Planning in Medan have tried to adjust the performance indicators in the agency strategic plan by setting goals and objectives. The improvement of indicators has also been made in the proposed revision of the Medan City RPJMD, but only covers 7 performance indicators.

In achieving the SDGs target, the KKBPK program affects the achievement of program points 3 and 5. The roadmap database of population in achieving the SDGs target for sustainable development has been stated in the Grand Design of Population Development in Medan City. However, cross-sector utilization is still not optimal in planning and policy making. So that it has an impact on the low achievement of the program in the field.

Bu tədqiqat işi, Medan şəhərində Dayanıqlı İnkişaf Məqsədlərinə nail olmaq üçün həyata keçirilən əhalinin proqramlaşdırılması, ailə planlaşdırılması ilə bağlı institusional işlərin analiz etməsini hədəfləyir. Dayanıqlı İnkişaf Məqsədlərinin həyata keçirilməsində kiçik və sağlam ailələri qurmağı hədəfləyən Əhali Proqramı, Ailə Planlaşdırılması və Ailə İnkişafı Proqramları mövcuddur. Araşdırmada keyfiyyətli bir yanaşma ilə təsviri iş metodikasından istifadə edilmişdir. Tədqiqatın nəticəsi olaraq, Medandakı Əhalinin İdarəedilməsi və Ailə Planlaşdırma İdarəsi, hədəf və vəzifələri təyin edərək, agentliyin strateji planına uyğun olaraq, fəaliyyət göstəriciləri düzəldilməyə çalışılmışdır.

Göstəricilərin yaxşılaşdırılması ilə bağlı Medan şəhərində 7 fəaliyyət faktoru ətrafında araşdırma aparılmışdır. Dayanıqlı İnkişaf Məqsədlərini həyata keçirmək üçün Əhali İdarəetmə və Ailə Planlaşdırma İdarəsi 3 və 5 sayılı proqramların uğurlu inkişafına təsir göstərmişdir. Dayanıqlı İnkişaf hədəfləri üçün əhalinin yol xəritəsi databazası çərçivəsində Medan şəhərində Böyük Əhali İnkişafı proqramı yaradılmışdır. Bunlarla birlikdə, sektorlar arasında istifadə edilən proqram və strategiyalar hələ də yüksək səviyyədə deyildir. Buna görə də qeyd edilən sahələrdə uğurların istənilən səviyyədə olmaması təbii ki, öz təsirini göstərir.

Это исследование направлено на анализ институционального работ по планированию семьи и осуществления програм для населения с целью достижения целей в области устойчивого развития в городе Медан. Цели в области устойчивого развития включают Программу населения, Программы планирования и развития семьи, направленные на создание небольших и качественных семей. В исследовании использовалась описательная методология с качественным подходом. В результате исследования Департамент управления народонаселением и планирования семьи в Медане попытался скорректировать целевые показатели в соответствии со стратегическим планом агентства, установив цели и задачи.

Было проведено исследование по 7 факторов для повышения показателей В городе Медан.
