

# **TEACHER TRAINING IN PAKISTAN: ISSUES AND POSSIBLE SOLUTIONS**

## **1. Introduction**

Education is indispensable to make progress in the knowledge-economy driven world. Education plays a crucial role in creation of human capital. It increases the output and competence of people and therefore produces skilled labor that leads the economy towards durable economic growth (Rasool). It opens new horizons for the learners to grow boundlessly. It has a great influence on all the fields of life. So, education is of great importance not only for the growth of an individual but also for the entire society socially, economically and morally. The key factor in this mass development of individuals and the society is the teacher who enables the learners to explore the world around them, investigate the phenomena of nature, and contribute to the stock of knowledge. Hence, teacher education becomes essential. Teacher education means knowledge of the subject matter as well as the skills to impart knowledge and develop skills in them (Grossman). In order to make teachers proficient in their content knowledge and equip them with necessary skills, various teacher training programs are held to polish the skills of these nation-builders. Similarly, teacher

education and teacher training specially have been emphasized in Pakistan. Several training programs for teachers of various grades are offered by the concerned training institutes. However, all is not well with these teacher training programs. This paper aims to explore the issues related to teacher training in Pakistan and how these issues can be resolved to improve the teacher trainings in Pakistan.

## **2. Research questions**

1. What are the major issues with teacher training in Pakistan?
2. How these issues can be resolved to improve the quality of teacher training in Pakistan?

## **3. Literature review**

### **3.1 Importance of Teacher Education**

“Education is not the filling of the pail, but the lighting of a fire” (Kelly-Gangi and Patterson). It means that the light of education spreads far and wide and teacher is the one who is a source of that illumination. Therefore, teacher training and performance are also very important and even the most essential input in field of education. A familiar fact about the role of quality teacher-training is that it is one of the best and most vital requirements to encourage, strengthen and improve education. Teacher education which can be defined as “the program of education, research and training of persons to teach from pre-primary to higher education level” (Osler and Starkey) covers skills of teaching, comprehensive pedagogy and professional skills.

### **3.2 Qualities of a Quality Teacher**

Kelly-Gangi and Patterson, mentioning the qualities of quality teachers state, “Quality teachers are life-long learners in their subject areas, teach with commitment, and are reflective upon their teaching practice.” They also affirm the fact that they possess good communication abilities and diagnostic skills. Effective teachers are also able to comprehend diverse learning styles and entertain cultural differences influences in their classrooms. They have complete information about child development, and have the aptitude to employ multiple techniques to meet student needs (Kelly-Gangi and Patterson).

Research also suggests that how well teachers teach heavily depends on training, ability, incentive, qualification, experience, and a multitude of factors (Memon). Quality teacher education is, therefore, undeniably playing a key role in nation-building and therefore it is imperative to train teachers so that they can shape a capable future society.

A well-defined and theoretically most useful example of quality teacher can be traced in a study which says that he is a quality teacher who influences student learning and development positively through a blend of subject mastery, grasp of extensive pedagogical skills, communication and interpersonal skills (Saeed et al.). Teaching skills plus pedagogical theory plus professional skills equal to teacher education.

Scholastic experiences, subject-related knowledge, competency, and accomplishment of teaching and competence of the teacher have active effect on the teaching and learning process. Several prior studies finds that teacher quality is the most important school-based factor in students achievement (McCaffrey et al.), and impacts of teacher on student learning have been identified to be long-lasting.

Teachers have a greater role to play in teaching and learning process. However, they are unable to fulfill their duties successfully well due to problems such as frequent and long breaks in their professional trainings and other difficulties which they face in teaching-learning process.

### **3.3 Islamic view of training and development**

Since Pakistan is a Muslim-majority country, Islam is practiced all over. The Islamic view of training and development holds great importance and needs to be revisited. Islam defines human development as “the development of both spiritual and human virtues”. Training at perfection in Islam is a high praised quality as persons possess varied desires and possess different means to achieve their goals. Islam initiated training and development fourteen hundred years ago which continued long after that. Initially, madrassas were set up that later turned into universities. Especially the universities in the cities of Fez, Cordoba, Tunis, Cairo, Baghdad, Damascus and Jerusalem marked considerable change in individual and social development (Hassi). These universities produced great intellectuals because of having teachers of high caliber who were trained informally and they rendered valuable contributions to their respective institutions in particular and society in general.

### **3.4 Status of Teacher Training in Pakistan**

Highlighting the significance of teacher education for Pakistan, Farah et al. states that the government of Pakistan must assist educational organizations, teachers, and put effort in teacher training program to achieve millennium development goals. This will result in increase of students’ performance (Farah, Fauzee and Daud).

Good standard of education is vital for proper development of any country and teacher education plays an indispensable part in regulating it. In Pakistan, the number of systematically and effectively running teacher trainings institutes is around two hundred and three (203). Additionally, the government of Pakistan has established almost three hundred (300) teacher resource centers. In addition to government institutes, there exist also private teacher trainings centers which train teachers and equip them with some pedagogical skills and provide them professional certificates (Statistics). Research also reveals that every year around 40,000 teachers are given trainings under these short term programs (Aly).

Like many other countries, Pakistan has formal system of teacher education. Curriculum wing designed PTC (Primary Teacher Certificate) and CT (Certificate of Teaching) Teacher Education Syllabi for pre-service teachers. And the Ministry of Education: HEC Islamabad devises syllabi for B.Ed. (Bachelor of Education), M.Ed. (Master of Education) and M.A. (Master of Arts) Education. Minimum requirements for PTC were Matriculation plus two years education. For CT, it was Intermediate, and for B.Ed. requirement is bachelor degree, and similarly for M.Ed. program pre-requisite is bachelor degree in education in Pakistan.

### **Issues in Teacher Training**

Pakistan faces certain issues with respect to education programs. The current and developing concerns of teacher training institutes are: (a) Teacher training institutions face financial limitations and are not sufficiently equipped to cater to the needs of modern teacher education system. (b) The teacher training institutes encounter grave shortage of facilities, for instance, teaching aids, buildings, library, furniture, text materials and other related resources. (c) Examination system at these institutes is not up to the mark, and (d) Teacher absenteeism, poor management, and inefficiency of administration are more underscored problems (Farah, Fauzee and Daud).

Research states that Pakistan teacher education program has been facing severe challenges in terms of quality, policy, and shortage of resources (Jumani and Abbasi). Some of the most issues that the research reveals are:

1. One of the problems is to acquire and attract the right individuals to become good teachers because desirable standards can never be achieved without attracting good quality candidates to the teaching profession. Since the candidates who apply and get selected for teaching are not so serious and thus do not benefit from these trainings.

2. Equipping teachers with the appropriate and right skills is also a challenge. Teachers must be prepared with applicable knowledge and teaching skills that can enhance student achievement by providing them pertinent guidance. Low levels of education and weak training are leaving teachers awarding certificates/degrees from teacher training Institution/Universities without the essential subject knowledge and pedagogical skills to provide the paramount conceivable instruction for every student.

3. Lack of resources in teacher training institutions/Universities is another challenge while discussing quality teacher training. It has been observed that teacher training education institutions have often been lack of resources including laboratories, libraries, reading materials, building, and information and communication technology facilities etc. all these affect professional development of teachers.

4. Yet another issue is to encourage teachers to perform their job effectively. Many reasons can be quoted including the low salary which affects teacher motivation greatly. It has also been noticed that “low levels of income have an unfavorable impact on teachers’ personal lives and their competence to do well in their jobs, as most of the teachers seek elsewhere for part-time teaching to increase their incomes.” (Ofoegbu). Demotivated teachers are seldom concerned about their professional development. Hence, teacher trainings become rather useless and ineffective for them.

5. Unfair distribution of qualified and effective teachers can be another challenge. In numerous countries, on one hand, well-trained teachers prefer to teach in schools located in urban areas where there salaries are relatively high and they can have amenities. As a result, students’ achievement is undesirable, where even parents unwantedly take out their children from school in rural areas.

### **Suggestions for revamping teacher training**

Although the teacher education system in Pakistan is inflicted with many problems yet there is always some room for improvement. A democratic society and the society where education and human development are held high, teacher quality and teacher education related issues are always a priority. (Cochran-Smith and Zeichner) Since Pakistan is on the path of democracy, serious efforts should be taken with regard to teacher education.

The findings of the study suggested that the problems of teachers could be resolved by producing an environment of trust and strengthening the process of accountability in the school systems, minimized political interference and merit must be followed in teacher recruitment, provision of facilities to teachers

and increase in teaching learning materials. Moreover, prevailing professional development programs should be run on systematic basis to improve teaching skills of teachers.

Besides, establishing well-trained teachers requires excessive investment in physical capital and human capital. However, most of low income countries like Pakistan suffer from lack of finance due to multiple reasons. It is suggested that policy makers should give more attention upon prompting teacher education even within their limited resources, if unproductive expenditure reduced and control corruption, so it is possible.

Moreover, teacher training should not be limited to programs of professional degrees. Online courses should be initiated and informal teacher training should be encouraged in the age of globalization.

### **Conclusion**

In conclusion, it is stated that progress without making strides in education is next to none. All socio-economic progress is directly related to development in education of which teacher is a pillar. Teacher is the one who guides, molds and transforms the tender minds and youth of the community or nation. In Islam, teacher's role is well-defined and he holds great responsibility of developing his students. This huge importance associated to teacher necessitates betterment in teacher education. Teacher training is an integral part of teacher education. Despite the efforts of the government of Pakistan to revamp the teacher training, there exist some serious issues such as attracting suitable individuals for teaching, equipping them with the appropriate and right skills, lack of resources in teacher training institutions/Universities, demotivation among teachers to perform their job effectively and polish their skills, unfair distribution of qualified and effective teachers.
